On 07/28/2017 at about 2330 hours, I was dispatched to the area of Counterpoint Estates in reference to a possible drunk driver that was last seen heading west bound on Belvedere Rd. Dispatch was advising updates via radio and advised that the car was white in color with Florida tag Y22 XFS and that it was last seen entering Counterpoint Estates. As I entered the development, I observed a gold in color vehicle traveling east bound on Belvedere Rd. The vehicle was holding up traffic to the point 4 cars were behind it traveling at a very slow speed. I turned around on the vehicle and as I got behind it, I observed the vehicle having a hard time maintain a single lane as it approached the intersection of Belvedere Rd and SR 7. I activated my PBSO in car dash camera to establish a driving pattern for the vehicle. As we were sitting at the light, the driver leaned over into the passenger side for about 5-6 seconds and while doing that the vehicle started to move forward slowly. The driver then slammed the brakes on and stopped abruptly. The driver did this on more than one occasion.

Once the light turned green the vehicle proceeded north on SR 7 in the far right lane. The driver had a very hard time keeping the vehicle in a single lane to the point of the vehicle was swaying back and forth from white line to white line. Once a pattern was established, I activated my red and blue emergency lights to conduct a traffic stop on the vehicle bearing Florida tag Y22 XSS. The vehicle came to rest in the far right lane just north of Business Pkwy on SR 7.

As I went to exit my vehicle to approach the driver, I noticed that the driver's vehicle was actually rolling backwards towards my vehicle. I put my car in reverse and hit the siren to get the attention of the driver at which she failed to hear. The vehicle continued backwards, going off the roadway and into grass area off the roadway. I yelled at the driver to put her car in park at which she finally did.

I made contact with the driver who identified herself as Jacqueline D. Seaman (DOB 8-4-1986). It should be noted that the driver's speech was very slurred and she could not tell me where it was she was coming from or what she was doing. I notified DUI 17 and had him respond to the scene for a further investigation into the fact of Seaman being possibly impaired to operate a motor vehicle.

This ends my involvement in this case.

# D.U.I. PROBABLE CAUSE AFFIDAVIT

**PERSONAL CONTACT**

**DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)**

On 07/29/2017 at approximately 0006 hours I responded to 1007 N State Road 7, in the Village of Royal Palm Beach, in reference to a DUI investigation. Upon my arrival I observed a gold Chevrolet Impala bearing Florida tag Y22XSS stopped on the east shoulder of the roadway facing north bound. I observed a white female wearing a blue dress in the driver's seat of the vehicle, alone. I then spoke with the stopping deputy, D/S Benson ID: 7332 who stated the following: The vehicle that she stopped was parked on the side of the roadway almost completely next to D/S Benson's patrol vehicle because she almost backed into her and the driver did not know how to place the vehicle in park. She also stated that the driver appeared "annihilated." D/S Benson stated that she first observed the Chevrolet in the Counter Point development (located at Belvedere Road and State Road 7). The driver was slumped over the steering wheel and she appeared to have her foot slip off of the brake, rolled for a little bit, smashed on the brake, then proceeded to turn onto State Road 7. D/S Benson stated she observed the vehicle swerve from side to side as it drove. She conducted a traffic stop of the Chevrolet at which time the driver attempted to put the vehicle in park but did not which caused her to roll backwards toward D/S Benson's vehicle. This caused D/S Benson to start to backup so that she would not be hit by the Chevrolet. She attempted to alert the driver to the issue by hitting her air horn. The initial call alerting the deputies to the Chevrolet was a "Mobile Eyes" call which stated that the vehicle with a tag of "Y22XFS" had struck a railing on Belvedere Road. D/S Benson stated that she was alerted to the Chevrolet because she had four cars behind her, holding them up. The driver, Jacqueline Seaman, did not provide D/S Benson with a driver's license but was located in DAVID and confirmed to be who she stated she was. She was also the registered owner of the Chevrolet (see D/S Benson's supp PC for further).

**OBSERVATION OF DRIVER:**

I then made contact with Jacqueline, identified myself to her, and asked her if she was okay or if she needed Fire Rescue. Jacqueline stated she was fine and did not need Fire Rescue. I observed that she was wearing a blue dress with no shoes as she sat in the vehicle. I also immediately observed the obvious odor of an unknown alcoholic beverage coming from her breath as she spoke. I observed that her eyes were red, glassy, bloodshot, and droopy. Her face was flush and droopy as well. Her speech appeared slurred, mumbled, slow, and unclear as she spoke. I asked her if she could put on any shoes which she attempted to locate. As she did so I observed what appeared to be fresh damage done to the passenger side quarter panel and front door. There were scrapes and dents which were about guardrail height. No reports of a hit and run or other crash had been reported since the call came out. Jacqueline mumbled something to me which I did not understand. She then asked if she could put the light on in the vehicle to locate her slippers which she did. As she reached for her mismatched sandals I observed that she was slow in her movements and fumbled with her belongings. Jacqueline took sometime to locate her slippers but ultimately went bare foot because she could not locate a matching slipper. I had Jacqueline follow me to the front of my marked PBSO patrol vehicle and asked her if she knew why she was stopped. She stated that she was going through a bad divorce as she started to weep. Jacqueline stated that she was stopped because she was swerving. I explained that she almost backed into another deputy which she appeared to not remember. I asked Jacqueline if she had any medical issues such as diabetes or seizures which she stated she did not.

**DRIVER'S STATEMENTS:**

She stated she wanted to go home and that she was on the way home to Purdy. She stated she had given someone a ride who lived in Counter Point. Jacqueline continued to speak which became very difficult to understand. Jacqueline stated she took Xanax for anxiety, no illegal drugs, and did not smoke any marijuana. She stated she had no issues with her eyes but wore glasses for driving which she stated she did not have on that night. She stated that she had no physical defects or injuries either. Jacqueline stated she had no issues with her speech and did not have issues walking around. I observed that Jacqueline had a circular sway as she stood still. I explained my observations to Jacqueline and asked her how much she had to drink that night to which she stated not enough to impair her but stated three beers as well. She stated she had them at approximately 2100 hrs at her parents house. She stated that she had food with her drinks as well. Based on my above observations I asked Jacqueline to submit to standardized field sobriety tasks which she stated she would do.

**ODORS:**

Obvious odor of an unknown alcoholic beverage on his breath

**SPEECH:** Slurred, slowed, mumbled, unclear

**ATTITUDE:** Calm, compliant

**CLOTHING:** Blue dress, no shoes

**MEDICAL/OTHER:** No medical issues (no diabetes or seizures), no physical defects or injuries, no issues with eyes (supposed to wear glasses to drive), no speech issues normally, takes Xanax for anxiety (no other medications), does not take illegal drugs or marijuana, stated had three beers, no shoes

**Other Observations:**

The overhead blue police lights were turned off prior to the tasks. Jacqueline's eyes tracked equally, the pupils were the same size and were appropriate for the lighting conditions, and no resting nystagmus was observed. Vertical gaze nystagmus was administered and was observed. Jacqueline moved her feet and arms from the instructed position; she continually moved her head during the task; she swayed in a circular motion as well during the task. Jacqueline also stumbled forward during the task.

**WALK & TURN:**

The white fog line of the roadway was used for the task. I explained and demonstrated the instructions for the walk and turn task to Jacqueline who stated that she understood. During the task I observed that Jacqueline had the following cues: couldn't keep balance while listening to instructions (moved arms up and feet from line, swayed side to side, stated she would not be able to do it but would do her best); started too soon multiple times; stops walking to steady self/regain balance throughout task; missed heel-to-toe on steps: 1, 2, 3, 4, 5, 7, 8, 9; stepped off the line on steps: 1, 2, 3, 4, 5, 7, 8, 9; used arms for balance (raises arms over six inches); did not count as instructed; improper turn (did not turn, just stopped and stated she could not do them); Taylor warnings were explained to Jacqueline after she stated that which she stated she understood. She wished to continue the tasks.

**ONE LEG STAND:**

I explained and demonstrated the instructions for the one leg stand task to Jacqueline who stated that she understood. During the task I observed that Jacqueline had the following cues: swayed side to side while balancing; used arms for balance (raises arms over six inches); put foot down twice (before 30 seconds) then switched feet and put it down two more times; task was stopped at 23 seconds due to Jacqueline stumbling backwards (did not want her to fall); could not maintain instructed position (moved feet and stumbled).

**FINGER TO NOSE:**

I explained and demonstrated the instructions for the finger to nose task to Jacqueline. I explained what is considered the tip of the finger and tip of the nose to Jacqueline who stated that she understood. Jacqueline also showed she knew her left from her right. During the task I observed that Jacqueline had the following cues: did not keep eyes closed and did not keep head back; failed to return arms to the side on each instructed hand; touched bottom and below nose on 1st, 3rd, and 6th instructed hand; touched side of nose on 2nd, 4th, and 5th instructed hand; used wrong hand for task (raised left when called for right on 5th instructed hand); swayed in a circular motion during task; tilted head back and closed eyes before being told to.

**ROMBERG ALPHABET:**

I explained and demonstrated the instructions for the Romberg with recitation task to Jacqueline who stated that she understood. I asked her to say her ABCs from A to Z without stopping and without singing which she stated she could. During the task I observed that Jacqueline had the following cues: swayed in a circular motion; head tilted forward; eyes opened; stated "and Z," couldn't stay in instructed position (moved feet); tilted head back and closed eyes before being told to; Jacqueline stumbled forward slightly and held onto the front push bumper.




