On the 20 day of November, 2019 at 10:45 (Specifically include facts constituting cause for arrest.)

During the months of September and October 2019, the West Palm Beach Police Department and Palm Beach County Sheriff's Office was made aware of a narcotic supplier that frequents the 900 block of 5th street, and 410 N. Tamarind Avenue in the city of West Palm Beach. The narcotic distributor was identified as Breon HICKS.

During this time period numerous controlled buys were conducted by confidential informants from persons who are believed to be involved with Breon HICKS` drug trafficking organization. During those buys, HICKS would direct the confidential informant to purchase narcotics from his workers and establish pricing for the narcotics.

During this time period constant surveillance was completed on HICKS where he was known to stay over night during the two month long investigation at 4223 Tazewell Ct. West Palm Beach Florida. During the entire investigation while conducting actual and electronic surveillance on HICKS, it was verified that he would stay at 4223 Tazewell Court almost every night for the duration of six weeks. During this surveillance it was learned that the owner and resident Jada Brody, stayed there every night with an unknown child.

On 10/30/2019 Your Affiant applied for and was granted a state authorized search warrant by the Honorable Judge Sharee Cunningham for the residence of Breon HICKS and Jada Brody which was 4223 Tazewll Court West Palm Beach Florida. Upon execution of the search warrant, Brody responded to the residence driving a white Hyundai SUV. The following items were located inside of the residence:

-Large freezer bag containing suspect marijuana that was located inside of the refrigerator (freezer side) in the kitchen. Marijuana tested positive for THC and weighed 213 grams which is consistent with distribution and not personal use. The bag

was clear on the top side and dark colored on the bottom side. The bag was not hidden inside of the freezer side of the refrigerator and was next to other frozen foods to include popsicles.

- small bag of marijuana on the kitchen counter weighing 9.9 grams
- A CubeSmart storage business card with access number *1689862 reference cube number 168
- Silver Apple Computer model A1278 FCC ID: QDS-BRCM1055
- White Apple cell phone with SIM 8901410427 0681757539
- ledgers (marijuana brands)
- Master Piece Arms 5.7x28mm Firearm and firearm boxes along with ammunition.
- US currency totaling \$4000 found in a purse in the master bedroom closet.
- narcotic equipment (vacuum seal bags and vacuum sealer) - located in front room

Upon completion of the search warrant, Agent Fuchsman commented out loud to other agents that were standing next to Brody saying that he has the same popsicles in his refrigerator that Brody had in hers. Brody commented in an utterance saying that she got the popsicles from Walmart. Agent Fuchsman thought that this was odd because the large distribution amount of marijuana bag in the freezer was next to the popsicles, showing that Brody had knowledge of items in the freezer.

After the final walk through of the search warrant, Brody was given an inventory of the items that were seized. Your Affiant transported the evidence to the West Palm Beach Police Department. Your Affiant tested the small marijuana (9.9 grams) which tested positive for THC. Your Affiant then tested the large bag (213 grams) with a Marijuana Duquenois-Levine number 5 Reagent, which revealed the presence of THC.

Based on the facts above there is probable cause to charge Brody with one count of possession of marijuana with intent to sell per F.S.S. 893.13(1A)2, and one count of possession of marijuana over twenty grams per F.S.S. 893.13
