 The Person taken into custody  
 committed the below acts in my presence.  was observed by \_\_\_\_\_ who told \_\_\_\_\_  
 confessed to \_\_\_\_\_ that he/she saw the arrested person commit the below acts.  
 admitting to the below facts.  was found to have committed the below acts, resulting from my (described) investigation.  
 On the 1 day of March 2018 at 1643  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On Thursday March 1, 2018 at approximately 1115 hours I was dispatched to \_\_\_\_\_ reference an allegation of child abuse.  
 Upon arrival I met with DCF representative Paula Arce who provided me with DCF intake report. The report stated :  
 "The reporter is the Assistant clinical manager at \_\_\_\_\_ The reporter became aware of the situation from \_\_\_\_\_, the pediatrician."  
 The DCF representative advised me the allegation reported is the child \_\_\_\_\_ was struck with a belt by \_\_\_\_\_ Jahazial Portal leaving several bruises on the child's body.  
 I was advised that the child \_\_\_\_\_ was absent from school.  
 The DCF representative and I went to the child's reported home address located at \_\_\_\_\_  
 Upon arrival, I met with the child's grandfather \_\_\_\_\_ who stated he lives at the residence with the child and the child's mother \_\_\_\_\_ stated the \_\_\_\_\_ was sick today and went to work with his mother at \_\_\_\_\_  
 The DCF representative and I made contact with \_\_\_\_\_ and \_\_\_\_\_ at the daycare.  
 \_\_\_\_\_ stated to us that on February 26, 2018 he was in the car with \_\_\_\_\_ stated he thought he and \_\_\_\_\_ were playing around calling each other names when \_\_\_\_\_ stated he called \_\_\_\_\_ a "Pig". \_\_\_\_\_ stated that \_\_\_\_\_ got very angry and stated to him " When I get home, you are going to get hit hard" and " You disrespected me in front of my wife."  
 \_\_\_\_\_ stated when they arrived to \_\_\_\_\_ took him in a room, locked the door and hit him twice with a belt in buttocks area. \_\_\_\_\_ stated \_\_\_\_\_ stated "Who am I?", while he struck him with the belt. \_\_\_\_\_ stated that no one else in residence witnessed he incident.  
 \_\_\_\_\_ showed me a large bruise to his right back thigh and another large bruise to his right butt cheek. The DCF representative took photos of the child's injuries.  
 I also met with \_\_\_\_\_, \_\_\_\_\_ who stated he showed her the bruises after the visit with \_\_\_\_\_ stated that she noticed \_\_\_\_\_ was in a little pain and was rubbing his backside. When she asked him what was wrong, he was reluctant to show her. He stated to her "Please don't tell \_\_\_\_\_" \_\_\_\_\_ advised her that \_\_\_\_\_ hit him with the belt. \_\_\_\_\_ stated that she took \_\_\_\_\_ to the pediatrician the following day because she as concerned about the amount of bruising \_\_\_\_\_ sustained.  
 The DCF representative and myself conducted a sworn taped interview with Jahazial Portal. Jahazial stated that he disciplined \_\_\_\_\_ when they arrived at his home because he disrespected him by using foul language in the car. Jahazial was very evasive when being questioned and refused to answer several questions without his lawyer present. Jahazial stated that he used a belt to discipline \_\_\_\_\_ for disrespect. He also stated that checked on the child after the incident \_\_\_\_\_ and only saw a red mark to his back side.  
 Jahazial also stated after we concluded the interview that he didn't understand why we couldn't give him a second chance that this was the first time doing this.  
 Based on the above to include my investigation and the injuries sustained I find probable cause to charge Jahazial Portal with FSS 827.03(2C) Child abuse with out great bodily harm.
