On 10/31/16 at approximately 01:44hrs I was conducting selective speed enforcement with Investigator D. Mercier #8236 in the area of Southern Blvd (SR80) and Fairgrounds Road which is located in unincorporated West Palm Beach, Palm Beach County, when I observed a black 2005 Toyota Highlander bearing Florida tag G77-1MS traveling westbound. I visually estimated this Toyota to be traveling faster than the posted speed limit of 50mph. I activated my in-car radar unit which emitted a clear high pitched Doppler tone which is indicative of a high speed. The radar unit showed an actual displayed speed of 81mph. I informed Inv. Mercier of the vehicle speeds and we elected to initiate a traffic stop on the Toyota. Inv. Mercier and I pulled into the lanes of travel and activated our emergency lights on our marked PBSO patrol vehicles getting the Toyota to yield in the area of Southern Blvd and 105th Avenue which is now in the Village of Royal Palm Beach.

Inv. Mercier approached the vehicle on the driver side and I on the passenger side. Inv. Mercier made contact with the driver, a W/F who identified herself by her Florida driver license as "JAIMARIE MOJICA". I made contact with the W/M passenger. With the windows of the vehicle being rolled down I immediately detected an odor of an unknown alcoholic beverage emanating from the interior of the car and noticed in plain view an open bottle of whiskey in a clear plastic bag on the rear floorboard. I observed Mojica to have extremely slow and slurred speech and her movements were slow and deliberate while retrieving the requested document. Mojica became quickly agitated and belligerent with Inv. Mercier, who was now beginning to attempt to conduct a possible DUI investigation. Mojica was alerted of Inv. Mercier's detections and grew increasingly aggressive. With Inv. Mercier standing in the open door, he asked for Mojica to exit the vehicle and she adamantly refused to comply with the lawful commands. Mojica then firmly grabbed the steering wheel with both hands. Inv. Mercier then gave a second lawful command to exit the vehicle. Mojica again refused now stating, "I know my rights!" With Mojica again refusing to comply, Inv. Mercier grabbed Mojica by the left hand and removed her from the vehicle and escorted her to the ground where she was taken into custody without further incident.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I stopped the defendant's vehicle, a black Toyota Highlander bearing FL tag G771MS, near the intersection of SR80 and 105th Ave, in the village of Royal Palm Beach, Palm Beach County, Florida, for speeding (81/50). (All speeds were determined by visual estimation and confirmed by proper pacing technique using PBSO pace car asset #70103 / VIN# 1FAHP2MK8FG119488, which was properly calibrated and certified at the time).

OBSERVATION OF DRIVER:

I made contact with the defendant, later identified by FL DL as, JAIME MOJICA. I observed that the defendant had red, watery, bloodshot eyes, slurred rambling illogical mumbling speech, and the odor of an unknown alcoholic beverage that came from her breath and intensified as she spoke to me. I asked if she had any medical problems, or took any medications. She said no. I asked how much she had had to drink. She said, "I'm just trying to go home."

I asked the defendant to exit the vehicle. The defendant refused, mumbling, "I know my rights. I'm not getting out of the car." I tried to give the Taylor Warnings and explain the evidence that I already had against her (red, watery, bloodshot eyes, slurred speech, odor of alcohol, 81/50, but she continually interrupted me and reiterated, "I'm not getting out of the car, I know my rights". I was eventually able to finish the Taylor warnings, but she would not answer when I asked her if she understood.

At that point, I found probable cause for arrest for DUI and resisting without violence. I removed her from the car, against her will, by using an arm bar takedown.

Pre Miranda / spontaneous roadside admissions: NA

Post Miranda roadside admissions: NA

Post Miranda admissions enroute to / or at BAT: REFUSED BREATH after Implied Consent, and the Q&A. She answered a few of the demographic questions then simply refused to speak or would only say, "nope. I don't understand."

Obvious odor of an unknown alcoholic beverage that intensified as the defendant spoke to me.




