### Probable Cause

On February 3, 2018 I was on routine patrol in my marked patrol vehicle in Palm Beach County. I was traveling southbound on I-95 (State Road 9) from 6th Ave S. I was responding to reports of a reckless vehicle that was traveling southbound on I-95 from Okeechobee Blvd. I was able to position myself behind the vehicle and observed a white four door BMW directly in front of me. I observed that the vehicle was swerving from left to right and was unable to maintain a single lane. I then activated my emergency equipment to initiate a traffic stop on the vehicle. The vehicle yielded to the right shoulder of the roadway south of Lantana Road. I then approached the vehicle from the passenger side and observed that the driver was the sole occupant of the vehicle. I identified myself and requested that the driver present a DL, registration and proof of insurance. He handed me a FL DL and was fumbling through papers. He eventually handed me a vehicle registration that expired in 2015. As I was talking to him I observed that he had a difficult time focusing his attention on me as I talked. When asked a question he would stop talking in the middle of his answer and would stare away from me. He had to be prompted multiple times to get a response. The driver was later identified as Jaime Camargo by his FL DL. I repeatedly asked him where he was coming from and he stated that he was coming from Twin Peaks in Boca Raton FL. He then stated that he was traveling to his house in Weston FL. As I talked to Mr. Camargo I observed that he had the odor of an unknown alcoholic beverage emitting from his breath as he talked. I also observed that he had bloodshot glassy eyes and slurred speech. I then requested that he step out of the vehicle and walk towards my patrol car. As he walked I observed that he was unsteady on his feet. As he stood in front of me I observed that he had orbital sway, blood shot glassy eyes and the odor of an unknown alcoholic beverage was emitting from his breath. I requested that he conduct field sobriety exercises and he stated that he

#### Horizontal Gaze Nystagmus

Before beginning the exercises, I checked to see if Mr. Camargo was wearing glasses or contact lenses. It was determined that Mr. Camargo was not wearing glasses or contacts. I then checked Mr. Camargo's eyes and observed equal tracking and equal pupil size. Mr. Camargo was instructed to place his feet together and place his hands down at his side. He then was instructed to keep his head still and follow the stimulus with his eyes and his eyes only. He was also instructed to keep looking at the stimulus until told not to. Mr. Camargo verbally indicated that he understood.

- Lack of smooth pursuit, left eye
- Lack of smooth pursuit, right eye
- A distinct and sustained nystagmus at maximum deviation in the left eye
- A distinct and sustained nystagmus at maximum deviation in the right eye
- An onset of nystagmus prior to 45 degrees in the left eye
- An onset of nystagmus prior to 45 degrees in the right eye

I also observed vertical nystagmus.

During the exercise Mr. Camargo had to be told to stay in the proper position and not to move his head during the exercise. I also observed Mr. Camargo to have orbital sway and glassy red eyes.

#### Walk and Turn Exercise

The area was level and free of debris. Mr. Camargo verbally indicated that he saw the line on the ground. Mr. Camargo was instructed to put his left foot on the line, then place his right foot on the line ahead of the left foot in a heel to toe manner. then demonstrated this position. Mr. Camargo was instructed not to begin until told to do so. Mr. Camargo verbally indicated that he has understood all instructions up to this point. Mr. Camargo was then instructed to take 9 heel to toe steps on the line when told to do so. I then demonstrated this. Mr. Camargo was then instructed to turn on the ninth step and to keep the front foot on the line and to take a series of small steps with the foot on the line. I then demonstrated this for Mr. Camargo. Mr. Camargo was also instructed to keep his arms at his sides and to watch his feet during the exercise. Mr. Camargo was also instructed to count aloud and to not stop once he begins the exercise. He was also instructed to keep his arms at his sides at all times.

Mr. Camargo began the exercise too soon and had to be told to wait and to get back into the starting position. He took 11 steps forward and 9 steps back. Mr. Camargo showed difficulty keeping balance during the instructions and the exercise. At one point he walked towards me and grabbed onto my shoulder as I was explaining the exercise. He was unable to walk in a straight line and walk diagonally. He completed the turn incorrectly, never touched heel to toe, or stepped on the line. He repeatedly complained of foot pain and stated that he would be able to do the exercise.

#### One Leg Stand Exercise

Mr. Camargo was instructed to stand with his feet together and to place his arms down at his side. Mr. Camargo was instructed to maintain that position until told to do so. Once told to do so, Mr. Camargo was instructed to raise one foot approximately 6 inches off the ground and to keep both legs straight with both arms at his side. He was also instructed to look at the elevated foot and count aloud in the manner of one thousand-one, one thousand-two and so on until told to stop. Mr. Camargo verbally indicated that he understood the instructions after I demonstrated to him.

Mr. Camargo was told to begin and raised his right foot. During the exercise Mr. Camargo displayed an orbital sway. He placed his foot down multiple times. Mr. Camargo also did not count aloud properly as instructed. He had to hop while trying to maintain balance. Mr. Camargo did not look down at his foot during the exercise. He repeatedly complained of foot pain and stated that he would be able to do the exercise.

#### Finger To Nose

Mr. Camargo was instructed stand with his feet together and arms at his side and to have his index fingers pointed out. He was instructed to not start and stay in that position until told to do so. He stated that he understood. I then demonstrated the position. Mr. Camargo was then instructed to when told to start to close both eyes and tilt his head back. When told to do so he was instructed to bring the hand I directed upward, touching the tip of your finger to the tip of his nose. I then demonstrated this. He was then instructed to after touching the tip of the nose to immediately bring his hand down to his

side. He stated that he understood. I then demonstrated and he stated that he understood. He was instructed to raise his hand in the following order, left, right, left, right, and right, left.

- Left: Missed tip of nose. Didn't return down immediately.
- Right: Missed tip of nose. Didn't return down immediately.
- Left: Missed tip of nose. Didn't return down immediately.
- Right: Missed tip of nose. Didn't return down immediately.
- Right: Missed tip of nose. Didn't return down immediately.
- Left: Missed tip of nose. Didn't return down immediately.

At approximately 0106 he was placed into handcuffs and under arrest for DUI. He was then searched and no contraband was found. He was then secured inside of my patrol car and taken to the Palm Beach County Jail. Once I arrived at the testing center I conducted a 20 minute observation of the subject. At no time did he take anything by mouth or regurgitate. I then requested that he provide a sample of his breath and he refused. Implied consent was read and he stated that he understood. He again refused to provide a sample. He was then booked into the county jail.


