At or near that time, Deputy McCann observed a red Nissan truck fail to make a complete stop at the stop sign at the intersection above, a violation of F.S.S. 316.074(1). I conducted a traffic stop on the Nissan on the northbound on-ramp to Interstate 95 from Indian Town Road. Upon approach, I made contact with the Nissan's driver, Defendant Andrew Mock.

Mock provided consent to search his Nissan, as witnessed by Sergeant Prieschl #6583. During the search, I found a piece of suspected rock cocaine that field tested positive for cocaine in the driver seat. Post-Miranda, Mock admitted to recently purchasing the suspected cocaine for \$20.00.
