	advised that her husband white male, James Andriote, was upset with her over a work colleague. Martiza told me that James had been drinking heavily throughout the night and was very angry. At approximately 0130 hours, Martiza stated that James woke her up in bed and started an argument. The argument turned physical when James pushed Martiza and grabbed her around her midsection while squeezing her. Martiza suffered a small bruise underneath her left ribs. It should also be noted that Martiza attempted to call 911 around this time but for some reason was not able to be met with police. I confirmed she called 911 by her cellphone log. I spoke with James who denied any physical altercation took place. James said that Martiza was the one who started the argument and was yelling at him. While talking with James, I detected a strong odor of an alcoholic beverage coming from his facial area. Based on my investigation, James was determined to be the primary aggressor and is being charged with Domestic Simple Battery F.S.S 784.03 (1A1). James was processed at BRPD and transported to Palm Beach County Jail. Martiza denied Fire Rescue and pictures of Martiza's injuries were taken. Martiza was given a domestic violence pamphlet.
