

She provided a sworn witness statement that she was in a verbal argument with her live in boyfriend James Kiely. The victim Maria stated the argument became physical when James grabbed her and pushed her in the living room. I did not observe any visible injuries to Maria. The victim Maria refused to get photographed about this incident.</p> <p>I then spoke with James Kiely who stated he was just talking to Maria and that he did not push her. James stated that Maria just wants him out of the house.</p> <p>Based on my investigation and the statements provided to me James Kiely was determined as the primary aggressor and was arrested for Domestic Battery. The defendant James Kiely was handcuffed doubled and checked for proper fit and transported to the Palm Beach County Jail.</p>
