


P	<p>On 9-25-16 at approximately 1814 hours I responded to 6428 Pompano Street in reference to report about a subject in the street with a shotgun. Dispatch stated the subject was wearing a white shirt, short, and was racking the shotgun near the street next to his mailbox. As we got closer to the address dispatch advised that the subject put the shotgun down and started to mow his lawn.</p>									
R	<p>Upon arrival to Hollywood Street and Harriet Avenue, I set up a three man team to approach the subject. As we approached we saw a white male wearing shorts, mowing a yard in front of 6429 Pompano Street, directly across from 6428 Pompano Street, the callers home. Upon making contact the suspect, later to be known as James Evans (W/M 4-5-58), we ordered the suspect to walk towards us with his shirt pulled up, revealing his waistband. He ordered the suspect to turn in a circle with his waistband revealed. No firearms were seen. We told the suspect to approach us with his hands up. He was patted down and was found to have no weapons currently on his person.</p>									
O	<p>I asked Evans if he has a shotgun. Evan stated that he did and it was in his home. I asked what happened earlier with his neighbor. Evan stated the following:</p> <p>"I decided to clean my shotgun near my mailbox next to the street. I racked the shotgun over and over to clean it. My neighbor didn't like it."</p> <p>I then asked Evans how racking his shotgun over and over near the road was a way of cleaning his shotgun. Evans then paused while looking at the ground for about 15 seconds. Evans then stated that he had an issue with his neighbor Ashcraft a few weeks earlier. Evans provided incident number 16-138495. He stated that he thinks Ashcraft sent a "thug" over to Evans home to scare his family. Evans stated that while he was mowing his yard today, Ashcraft was looking at him from inside his garage and smiling.</p>

Evan stated that he wasn't going to let Ashcraft think he could get away or harm people inside his home, so he got out his shot gun and walked to the mailbox with it. Evans stated that he looked right at Ashcraft and started to racking the slide of the shotgun over and over to intimidate Ashcraft from thinking he could send over "thugs" to his home. The shotgun was pointed down the street to the east.


I made contact with neighbor Michael Ashcraft (W/M 2-13-62) who stated the following:

"I was sitting in my garage watching videos on my phone and laughing at them. My neighbor Evans was mowing his yard. When I looked up, Evans was standing and just staring at me. The next thing I know Evans came out of his house with a shotgun and walked to the edge of the street next to his mailbox. Evans stared right at me and began to rack his shotgun over and over. I ran inside my home in fear for my life. I called the police. When I looked back out of my garage Evan was back mowing his yard again. I wish to prosecute to the fullest extent of the law."

Officer Yochum (ID 383) took photos of the shotgun that was inside the home that Evans stated he racked by the street. It was an older style black barrel shotgun with wooden slide handle.

I then placed Evans under arrest for improper exhibition of a firearm. He was TOT'd to Palm Beach County Jail with no issues.

My investigation found that Evans unlawfully, in the presence of one or more persons, did exhibit a shotgun, a dangerous weapon or firearm, in a rude, careless, angry or threatening manner, not in necessary self-defense, contrary to Florida Statute 790.10.
