On the 7 day of December, 2017 at 18:45 (Specifically include facts constituting cause for arrest.)

On 12/07/2017 at approximately 1818 hours, I responded to 321 W. Camino Real in reference to a disturbance.

Upon my arrival, I quickly observed (while exiting my vehicle) a white male who later came to be known as James Kilburn yelling, screaming, and cursing in an irate manner at two other white males named Brandon Abbott and Charles Burbage Jr. (who are staff members of Boca House). At this time, I immediately requested BRPD dispatch to start me another unit to the scene.

While walking towards the entrance of Boca House I observed Charles Burbage Jr. tell Kilburn to calm down and to stop cursing at staff members. At that time, I observed Kilburn make a hammer fist and strike Burbage Jr. on his lower left stomach as well as on his left hand.

I immediately announced myself as Boca Raton Police and requested piercingly that Kilburn move away from Burbage Jr. and sit down. It should be noted that he complied with my commands. Momentarily after, Officer Codling arrived on scene and I placed Kilburn into handcuffs.

Officer Gannon then arrived on scene and both he and Officer Codling stood by with Kilburn as I spoke separately with Brandon Abbott. Abbott informed me that Kilburn voluntarily discharged himself from the facility. He stated that he and Burbage Jr. were trying to calm Kilburn down because he was yelling, screaming, and cursing at staff members irately as he was exiting the facility. Abbott stated that he and Burbage Jr. were going to try and get Kilburn further assistance and were trying to make arrangements to take him to another treatment facility.

I spoke to Burbage Jr. and he stated the same as Abbott and acknowledged that he was

trying to compose Kilburn and informed him to stop acting irately and shouting at staff. Kilburn subsequently proceeded to strike (hammer fist) him in the lower left side of his stomach. According to Burbage Jr., Kilburn additionally struck him on the top of his left hand. It should be noted that Burbage Jr. did sustain bright bruise marks throughout the entire top portion of his left hand. The color of the bruises along the top portion of his left hand ranged from black and blue and some areas were red in color.

Burbage Jr. stated that he did want to prosecute but did not want BRFD to respond to examine him. He stated that he would go to the hospital on his own if the discoloration worsened. Additionally, Burbage Jr. did not want to complete a written statement form however pictures of his injuries were taken and submitted into BRPD evidence for safekeeping.

Based on my investigation, I placed James Comstock Kilburn under arrest for simple battery, pursuant to F.S.S 784.03(1A1) at 1845 hours.


James Comstock Kilburn was transported to BRPD facility for booking and processing and subsequently taken to Palm Beach County Jail.
