 On the **6** day of **June**, **2018** at **19:59** (Specifically include facts constituting cause for arrest)

On Wednesday 6-6-2018, at approximately 1934 hours, I was dispatched to 103 W Palmetto Park Rd in reference to a disturbance.

Upon arrival, Officer Gannon was with a w/f identified by her Florida driver's license as Marion Stamm and a b/m identified by his Florida driver's license as Damion Dawkins. I spoke with Dawkins who advised he was the Lyft driver for Stamm and her male companion (later identified as James Gatewood). Dawkins advised he picked up Stamm and Gatewood at a Frank and Dino's in downtown Boca Raton and was driving them to a predetermined address set forth by Gatewood using the Lyft app. Dawkins drove Stamm and Gatewood to the area of 103 W Palmetto Park Rd as Gatewood grew increasingly agitated and began yelling at him. Dawkins advised Gatewood stated "this not where I'm going keep driving" and "fucking drive before I fucking I kill you" and observed Gatewood strike Stamm on the right side of her face with an open hand while she was trying to get out.

I then spoke with Stamm who advised she and Gatewood went out for drinks at a restaurant in Boca Raton then decided to get a Lyft to go home. In the Lyft ride Stamm advised the Lyft driver drove them to 103 W Palmetto Park Rd at which time Gatewood became angry they were not going to the correct address. Stamm advised the Lyft driver told her and Gatewood to exit the vehicle at which time Gatewood grabbed her arm as she was attempting to open the door and slapped her on the right side of her face with an open hand. Both Stamm and Gatewood exited the vehicle and Gatewood proceeded to walk away from the scene eastbound on W Palmetto Park Rd. Boca Raton Police arrived on scene and Officer Rafalko located Gatewood at W. Palmetto Park Rd and Federal Hwy.

I then met with Gatewood who advised he and Stamm went to Frank and Dino's for food and drinks. Gatewood advised they both had a few drinks and then called for a Lyft to go home. Gatewood advised the Lyft driver drove them to the wrong location and they got out of the car. Gatewood stated he and Stamm had a verbal argument but it never became

It should be noted I did not see any visible marks on Stamms face and Stamm advised she could not write therefor did not provided a written statement but her statemtns were captured on body cameras. Dawkins provided Officer Gannon a sworn audio statement. Stamm was provided the Legal Rights and Remedies Pamphlet.

Based on my investigation and the detailed statement from Stamm, James Gatewood was placed under arrest at 1959 hours pursuant to FSS 784.03(1A1) simple battery (domestic) after he grabbed his girlfriend and struck her in the face during an argument. Gatewood was turned over to Palm Beach County Jail for processing.
