 On the 14 day of September, 2019 at 23:53 (Specifically include facts constituting cause for arrest.)

On Saturday, September 15, 2019 at approximately 0024 hours I arrested James J. Lukezic (W/M DOB: 08/23/1977), for simple battery as pursuant to F.S.S. 784.03(1) (a) (1). The details are as follows:

On Saturday, September 14, 2019, at approximately 2353 hours, I responded to the Colony Hotel (155 Hammon Ave, Palm Beach) in reference to a delayed battery call. Upon my arrival, I met with the caller Amber Rittenhouse Weeden (W/F DOB: 09/20/1993). Weeden stated that she had been drinking alcoholic beverages with the offender, James J Lukezic (W/M DOB: 08/23/1977), her employer, at Cucina Restaurant (247 Royal Poinciana Way, Palm Beach). Weeden further stated that they both utilized an Uber to return to the Colony Hotel, where they were staying.

Upon arrival to the Colony Hotel, Weeden stated that only one room had been reserved for the both of them, instead of two separate rooms, as she was made to believe. Weeden stated that she and Lukezic entered the room they were sharing to go to sleep. Weeden further stated that while she was laying on her own separate bed, clothed and under the covers, Lukezic undressed his pants and underwear, leaving only a polo shirt on. Weeden further stated that while naked and displaying an erection, Lukezic jumped on top of her, made unwanted physical contact with her, and attempted to touch her breasts. Weeden pushed Lukezic off of her telling him to stop. Weeden then fled to the bathroom and locked herself in, to avoid any further contact with Lukezic. Weeden, when able to, fled to the bar located in the Colony Hotel and contacted the Palm Beach Police Department.

Myself, and Sergeant Watson made contact with Lukezic inside his room in the Colony Hotel, room number 305. Upon initial contact, Lukezic was observed wearing a polo shirt, and was naked from the waist down, corroborating Weeden's statements. Lukezic was further observed to be swaying off balance as he stood, to have slurred speech, and to have the smell of alcohol beverages emanating from his breath. Lukezic refused to let us

After getting dressed, he stood in the doorway and refused to come out. After asking him to step outside his room several times, he eventually did and was informed of the allegations Weeden made against him. In response to the allegations he stated "nothing happened" and refused to say anything else.


Based upon my investigation I arrested Lukezic for simple battery as pursuant to F.S.S. 784.03 (1) (a) (1) .


