The following occurred in the City of Delray Beach, County of Palm Beach, FL.
 On 04/17/17 at 1754hrs I responded to 211 NW 1st Ave. in reference to a civil matter between a client and a recovery house. While responding to the scene, Dispatch advised there was a second caller who stated there was a verbal argument taking place in the roadway. Dispatch stated the second caller refused to identify themselves to the call taker. I arrived on scene and observed a white female (initial complainant) and a white male (later identified as James Phillip Stonikas) standing on the sidewalk. Stonikas appeared to be under the influence and had blood shot, glassy eyes. During my questioning to the complainant, Stonikas was instructing the complainant not to answer my questions. Stonikas insisted on speaking for the complainant. The complainant stated she was 22YOA and I confirmed she was the one who called for the police. I asked Stonikas if he was the complainant's attorney and he replied "No". I asked Stonikas if he was related or married to the complainant and he replied "No". Due to Stonikas interfering with my questioning, I ordered Stonikas to leave the scene. Stonikas initially refused to leave the scene and began to question me. I again ordered Stonikas to remain on the sidewalk next to my patrol vehicle on the west side of the roadway. After several orders, Stonikas complied with remaining off the scene. I walked the complainant across the roadway to the east side to speak with the property owner. While I was speaking with the complainant, Stonikas walked into the roadway and began screaming toward the complainant. I instructed Stonikas to return to the west side of the roadway next to my patrol vehicle. Stonikas refused this order and continued to interfere. The incident was captured on my body worn camera.

Based on Stonikas disobeying several lawful orders from a law enforcement officer, Probable Cause does exist to charge James Phillip Stonikas with Resisting Officer without Violence FSS 843.02.
