

	<p>arrived and spoke to Sergeant Dubinsky who stated he heard a female screaming "get off me; let me go; let me leave".</p> <p>I spoke with white female [REDACTED] who stated she has been dating James Becker for approximately five years. [REDACTED] stated she got into an argument with Becker, who is extremely intoxicated, so she decided to leave. She said when she got into her car a scuffle started over her leaving. [REDACTED] stated Becker did not want her to leave and was trying to prevent her from doing so by grabbing the keys from out of her hands. [REDACTED] stated she was clinging onto the keys, because she feared he would take them and throw them into the lake. During this scuffle [REDACTED] sustained a laceration to her left forearm, right pinkie, and left thigh. [REDACTED] stated it happened so fast she is not sure whether Becker caused the lacerations or the keys did. I observed the lacerations to [REDACTED] person that would corroborate her account of the events.</p> <p>I spoke with Becker who corroborated that they got into an argument tonight. Becker stated [REDACTED] was trying to leave and he stopped her and was trying to take the keys from out of her hand. Becker had a laceration to his left wrist and right ring finger that he stated he sustained from trying to grab the keys, and was not caused by [REDACTED]. Becker appeared to be intoxicated, I could smell a pungent odor of an alcoholic beverage emanating from his person.</p> <p>Based on my investigation I was able to develop probable cause for the crime of battery (domestic in nature). My investigation determined Becker actually and intentionally touched [REDACTED], against her will, contrary to Florida State Statute 784.03(1). Both parties' injuries were concurrent with their statements.</p> <p>Becker was placed under arrest and transported to the Boca Raton Police Department for processing. Once processed he was transported to Palm Beach County Jail.</p> <p>[REDACTED] was provided a Domestic Violence pamphlet. Photos of [REDACTED]'s injuries were taken and entered into BRPD evidence. Becker refused to have pictures taken.</p>
