On March 14, 2018 at approximately 1711 hrs, I met with the Palm Springs officer at Bank of America, 1758 S Congress Ave, in reference to a possible road rage incident. The incident took place on FL Mango Rd northbound at Arabian Rd East. I mader contact with Jessica Wade. Jessica told me she was northbound on FL Mango Rd at Arabian Rd W, when a white Ford Pickup, FL tag 147 QKE, who was southbound make a u-turn in front of her and causing her to brake suddenly as not to hit the vehicle. Jessica told me she got in the left turn lane to go west on Arabian Rd W and the white pickuip then pulled around her to get in front. The passenger then held up what appeared to be a handgun and shook it. Jessica told me she just put up her hands and did not know what to do, She told she was scared and shaking.

I later made contact with the male in the white pickup and his girlfriend at the Lake Clarke Shores Police Department. I advised white male, identified as James Roland Hitchens, 05/24/1983 and his girlfriend Tory Kay Hall, 09/29/1959. I told James I was conducting and investigation of aggravated assault with a weapon(handgun),and I was going to read his Miranda warning from a preprinted card. After reading his Miranda, I asked him if he nderstood them and he stated< "Yes." I asked Tory what took place and she told me she missed her turn and made a U-turn in order to go west on Arabian Rd W. and that is when James did what he did. I asked James what he did and he told me he got the gun out of the glove box, still in holster and held it up and shaking it. James told me he never pointed at anyone. Both statements were recorded on body cam.

Due to the confession and the findings I feel that htere is probable cause to charge James with Aggravted Assault as he did intentionally and unlawfully threaten by word or act to do violence to the person, Jessica Wade, coupled with a apparent ability to do so hold up a handgun and shake it, which created a well-founded fear in Jessica Wade, that such violence was imminent and further did commit the assault with a handgun, deadly weapon according to FL Stastute 784.021 (1)(a) 3rd Degree Felony.
