

N A R R A T I V E	<p>Ofc. Hall and I arrived on scene and made contact with Freidman. Friedman was in front of his residence waiting for our arrival. He was calm and cooperative. He was wearing a black t-shirt with camouflage pants and no shoes. Ofc. Hall entered the residence and made contact with [REDACTED] [REDACTED] appeared upset and began crying. She stated the following: She has an apartment nearby; however, she lives with Friedman. They have been dating for numerous years. Friedman was released this morning from the hospital, where he was at due to an overdose. They began an argument in their bedroom. Freidman accused her of being a bad girlfriend. He grabbed her by the neck and forcefully pushed her inside the open closet. He then told her to get out of his house. She complained of neck pain; however, no injuries were visible at this time. She denied any medical treatment.</p> <p>Ofc. Hall spoke to Friedman, who stated the following: He stated she pushed him but denied choking her. Friedman did not report any injuries.</p> <p>Based on [REDACTED]'s statements Friedman was arrested at 0808 hours.
