The following occurred in the City of Delray Beach, County of Palm Beach, FL.

On 04/12/18 at 0030hrs, I responded to 1595 Spring Harbor Dr. #R in reference to a domestic dispute and possible overdose. I met the complainant/offender (James William Altman) who stated his girlfriend (Elizabeth Belton) was acting erratic and overdosed on an unknown amount of pills. I observed Belton face down on the bathroom floor and attempted to wake her up. I instructed Altman to go outside the residence with Ofc. Skinner and Ofc. Saint-Martin. Belton attempted to walk out to the living room but fell to the ground. Belton became very emotional and uncooperative. Belton stood up in an aggressive manner and was placed in handcuffs. When Belton was placed in handcuffs, Altman attempted to come back into the residence ignoring officer's commands to remain outside. Altman had to be restrained and placed in handcuffs. After DBFD arrived on scene, I escorted Belton out of the residence onto the 3rd floor landing. Belton became aggressive again and attempted to pull away from me. I grabbed Belton's arm and pushed her in the chest against the wall. While restraining Belton, Altman became angry and began screaming toward me that I injured Belton. I escorted Belton down to the parking lot with the aid of DBFD. Once DBFD secured Belton to the stretcher, I returned upstairs where Altman was still angry and being verbally abusive toward officers. I placed Altman in handcuffs due to his erratic and emotional behavior and ordered him to sit down on the couch. Altman refused to remain seated on the couch and had to be instructed several times to remain seated for his safety and the safety of the officers. Altman demanded several times to have the handcuffs removed and made the threat toward me that he would "kick my fucking ass". I informed Altman he could not threaten a police officer and Altman stated "I don't give a fuck".

Based on the above facts, Probable Cause does exist to charge James William Altman with Corruption by Threat Against Public Official FSS 838.021(3B) and Resisting Officer w/o Violence FSS 843.02.
