**DRIVING PATTERN:**


Crash case. Driver was operating a Honda Accord. Fell asleep behind the wheel while driving to a Domino's Pizza. Driver struck a parked vehicle. Two witnesses, Jennifer Izquierdo and Ashley Ramnauth, observed the driver behind the wheel. Ofc. Haag #151 arrived on scene first, along with other officers for assistance. Ofc. Haag was the reporting officer for the crash. I observed Abbott outside of her vehicle, and was conversing with the officers on scene. Jaime admitted to officers on scene of drinking alot (alcoholic beverages). I was the investigative officer as I had reason to believe Abbott was impaired. Photos taken of Abbott's veh, and parked veh. I placed my patrol vehicle in a position to perform roadside tasks. I activated my Watchguard in-car video with wireless audio transmitter. I told Abbott the crash investigation was over, and that I was "switching hats". I told Abbott that we were going to perform roadside tasks. I read Abbott Miranda Rights from a card. Abbott kept interrupting me and asking me if she was going to jail. Abbott initially refused to do roadside tasks. Abbott then stated she was going to do them. As Abbott spoke, a very strong odor of an unknown alcoholic beverage, emanated from her mouth. Abbott's body swayed, and she kept touching me. Abbott admitted to being on 3 anti-anxiety medications. After the roadside tasks were completed, I had Probable Cause to place Abbott under arrest for DUI. Abbott was placed in handcuffs (double locked and checked for tightness). Abbott told me "I'm going to jail, really?". Ofc. Gonzalez #131, a female officer, was on scene, and performed a search of Ahhntt


