On June 21, 2016 at approximately 1931hrs I responded to the Home Depot located at 6800 Okeechobee Boulevard in unincorporated Palm Beach County Florida, in reference to retail theft. Upon my arrival on scene I met with the asset protection (AP) specialist Ernst Laquerre, in the AP office. AP Ernst already had a white male who was later identified by way of Florida DL as Jamie Mcelfresh, in custody with his handcuffs. AP Ernst told me that he witnessed Jamie while on the sales floor conceal a GB Pavilion Kitchen Faucet in his pants and then observed Jaime conceal a Ring Pro Video Doorbell in his front pocket. AP Ernst then followed Jaime to the front register's where he observed Jaime pass all points of sale without making any attempt to purchase the concealed merchandise. AP Ernst completed a PBSO sworn typed statement detailing his observations. AP Ernst showed me surveillance video of Jaime passing all points of sale, prior to being taken into custody. AP Ernst stated he would have to supply the surveillance video at a later date. AP Ernst provided me with a receipt showing the total amount of merchandise stolen as being \$347.00.

Once I confirmed that a crime was indeed committed by the male in custody I placed Jaime under arrest and into my PBSO issued handcuffs, which were double locked and checked for proper fit. I then secured Jamie into the rear passenger compartment of my patrol vehicle and turned on my in-car-video system. I read Jamie his Miranda rights from a PBSO issued Miranda card and Jamie requested his lawyer, I asked Jamie no further questions regarding the crime. Jamie was then turned over to PBSO transport deputy.

Based on the above facts, evidence and statements made by Ernst Laquerre I find that probable cause exists to find Jamie Mcelfresh in violation of F.S.S. 812.014(2)(C) Grand Theft.
