

(Specifically include facts constituting cause for arrest.)</p> <p><b>On January 27th, 2018 at approximately 0006 hours, I was dispatched to the Shell Gas Station located at 242 South Congress Avenue located within unincorporated West Palm Beach, Florida in reference to a delayed domestic battery that occurred at 312 South Congress Avenue.</b></p> <p><b>Upon my arrival, I met with the complainant who was later identified by Florida drivers license as Thomas Edward Delaney. Upon speaking with Delaney, he appeared to be very calm and did not appear to be upset. I immediately noticed a small laceration to his bottom lip which contained a small trace of dried blood. Delaney's bottom lip was also red and slightly swollen. Delaney refused emergency medical attention and declined to be transported to a hospital. Delaney did not appear to have any other physical injuries. Delaney stated that his ex-girlfriend, who he later verbally identified as Janessa Nicole Olavarria (W/F, DOB: 09/28/1988), punched him once in the mouth with a closed fist. Delaney and Olavarria were in a relationship together for approximately (5) years and resided together as a family. They do not have any children in common. Both subjects have been separated for approximately two (2) months and no longer live together. Delaney stated that the following events occurred on January 26th, 2018 at approximately 2330 hours between him and Olavarria inside of the Ultra Gentlemen's Club located at 312 South Congress Avenue:</b></p> <p><b>Delaney was seated at the bar within the nightclub, when he was approached by Olavarria. Delaney stated that he did not have any knowledge that Olavarria was at the nightclub upon his arrival. While Delaney was sitting alone at the bar, Olavarria came up to him and asked why he was there. Olavarria then unexpectedly punched Delaney once in the mouth with a closed fist, which caused the small laceration to his bottom lip. Delaney stated that he did not touch Olavarria during the incident and her actions were completely unprovoked. According to Delaney, Olavarria has physically struck him in the past, however he has never reported the past incidents to law enforcement.</b></p> <p><b>After speaking with Delaney, I then attempted to locate Olavarria at the nightclub and I was met with negative results. I was approached on scene by Olavarria's friend, who was later verbally identified as Brittney M. Charney. Brittney stated that she observed Delaney and Olavarria in a verbal argument.</b></p> <p><b>*** Continued on Page 2***</b></p>

During the argument, Delaney grabbed onto Olavarria's wrist, at which point Olavarria struck him with a closed fist. According to Charney, Olavarria did not appear to have any physical injuries and left the scene prior to my arrival. It should be noted that Charney refused to cooperate with my investigation any further and refused to provide a sworn statement of the incident. I attempted to contact Olavarria several times via telephone, however I was met with negative results.

Delaney completed a sworn written statement of the incident and photographs were taken of his injury. I presented Delaney with a familiarization photograph of Olavarria utilizing the Driver and Vehicle Information Database (DAVID) website, to which he positively identified Olavarria as the suspect.

Based upon the victim's physical injury, which is consistent with the statement that he provided to me of the incident, I determined probable cause to charge Janessa Nicole Olavarria with Simple Battery (domestic related) pursuant to F.S.S. 784.03(1)(a)(1) by actually and intentionally striking the victim against his will.
