

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 12/22/16 at 9:17 p.m., Palm Beach Gardens Police Dispatch advised of a silver Honda that was swerving with a white female driver. Officer Tiyaloglu located the vehicle on Alternate A1A southbound at Burns Road. The Honda, bearing Florida tag 951YKS was stopped in the left lane at a red light. When the light changed the Honda swerved into the right lane affecting other traffic. The Honda corrected and at the traffic light for the Promenade plaza, the Honda started to turn into the plaza and then swerved back into the left travel lane. Officer Tiyaloglu activated his emergency red and blue lights to stop the Honda. The Honda stopped in the left turn lane on Alternate A1A at Lighthouse Drive.

OBSERVATION OF DRIVER:

Officer Tiyaloglu observed that the driver, Janeth Castro-Morningstar had glassy eyes and appeared lethargic. I arrived on scene and Officer Tiyaloglu briefed me on his observations. I made contact with Castro-Morningstar and I smelled the odor of an unknown alcoholic beverage coming from her breath as she spoke, her speech was slightly slurred, her eyes were glassy and a little red. I asked Castro-Morningstar to exit and when she did, she was unsteady on her feet, swaying the entire time.

DRIVER'S STATEMENTS:

stated she had two beers around 7p.m. Told Officer Tiyaloglu she had nothing to drink. At the BAT during the twenty minute observation she stated she had a vodka soda and a "Stellar".

ODORS:

odor of an unknown alcoholic beverage coming from her breath as she spoke




