


<p>I responded to 11783 Fox Hill Cir, Unincorporated Boynton Beach, Palm Beach County in reference to a Simple Battery (Dating Violence).</p>								
<p>Upon my arrival I made contact with the victim, David Carberry, who was inside the residence. He stated to me that he was having an argument with the daughter, Kristal McFarland, of his girlfriend, Janice McFarland. He stated over and over that during the argument he did not hit anybody. He made no allegations at this time that he was struck during the altercation.</p>								
<p>I then spoke with the defendant, Janice McFarland. She stated that David was having an argument with her daughter Kristal. She stated that she stepped in between the two of them and that David started yelling at her as well. She stated that she told David that if he did not stop yelling at them that she would slap him. David continued yelling at the two females and Janice slapped him. David then slapped her back and pushed her. She had been checked by EMS prior to my arrival.</p>								
<p>D/S Vespi spoke with the daughter and witness, Kristal. She stated in a written sworn statement that David was intoxicated and was yelling at her. She stated that her mom came up stairs and asked him to stop. She stated that David the snapped and struck her mom.</p>								
<p>I went back inside and spoke with David. I asked him again what happened during the argument when Janice got between him and Kristal. He stated that she swung at him and he blocked it with his arm. He showed me a red scratch on his right bicep that was consistent with his story. He stated that he did not want to be seen by EMS and that he did not want to go to a shelter. He stated that he did not want to press charges for the battery.</p>								
<p>D/S Vespi supplied David with a domestic rights brochure and a victim rights from. D/S Vespi attempted to take photos but David refused. David wrote a written statement saying that the incident was resolvable and that he did not want to press charges.</p>								
<p>The domestic hotline was notified in reference to this case (level 2).</p>								
<p>Based on my investigation I found probable cause that the defendant Janice McFarland was the predominant aggressor in this case. I found probable cause to charge her with Simple Battery (Dating Violence) pursuant to Florida State Statute 784.03 (1A1).</p>
