PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
ON 09/24/2017 AT 0130 HOURS, I WAS CONDUCTING MOVING TRAFFIC ENFORCEMENT IN THE AREA OF SOUTHBOUND STATE ROAD 7 (US HWY 441), IN THE AREA OF ROYAL PALM BEACH, AND WELLINGTON, SOUTH OF SOUTHERN BLVD. I WAS IN A MARKED PBSO PATROL VEHICLE, EQUIPPED WITH AN IN VEHICLE CAMERA SYSTEM, RED AND BLUE LIGHTS AND SIREN. I WAS DRIVING SOUTHBOUND ON SR 7, WHEN I OBSERVED A BLACK MAZDA FOUR DOOR THAT HAD AN ATTACHED TAG OF DYV860, OUT OF FLORIDA. I OBSERVED THAT THIS VEHICLE WAS SPEEDING, AND WAS HAVING TROUBLE STAYING WITHIN ITS LANE. I OBSERVED THAT THE VEHICLE CROSSED OVER THE LANE LINE AS IT CROSSED THE INTERSECTION OF VICTORIA GROVE BLVD, FROM THE NUMBER TWO LANE (MIDDLE) TO THE NUMBER THREE LANE (OUTER), THEN CORRECTED BACK INTO THE MIDDLE LANE. THE VEHICLE CONTINUED TO DRIVE SOUTH, WHERE IT CONTINUED TO HAVE DIFFICULTY STAYING WITHIN ITS LANE, WHERE IT CHANGED LANES FROM THE MIDDLE LANE TO THE NUMBER ONE LANE (INNER). THE VEHICLE CHANGED LANES WITHOUT SIGNALING, AND NEARLY STRUCK THE CURB BEFORE CORRECTING. THE VEHICLE THEN ACCELERATED TO 60 MPH IN A POSTED 30 MPH ZONE. AS I CHANGED LANES INTO THE INNER LANE TO GET BEHIND THE VEHICLE, I OBSERVED THAT IT STRUCK THE STRIPED LANE LINE BETWEEN INNER AND MIDDLE LANE. I HAD MY IN VEHICLE CAMERA ACTIVATED TO OBSERVE THE DRIVING PATTERN OF THE DRIVER. AS I WAS INFORMING DISPATCH OF THE TRAFFIC STOP, THE VEHICLE THEN FAILED TO STAY WITHIN ITS LANE, DROVE NEARLY HALF OF ITS VEHICLE IN THE MIDDLE LANE, THEN CORRECTED INTO THE INNER LANE, WHERE I THEN CHOSE TO CONDUCT A TRAFFIC STOP ON THE VEHICLE FOR THE OBSERVED VIOLATIONS. I CONDUCTED A TRAFFIC STOP ON THE VEHICLE FOR THE VIOLATIONS, BY ACTIVATING MY OVERHEAD LIGHTS AND SIREN. THE VEHICLE THEN PULLED OVER INTO THE INNER TURN LANE FOR FOREST HILL BLVD.

OBSERVATION OF DRIVER:

AS I APPROACHED THE DRIVER'S SIDE OF THE VEHICLE, I OBSERVED THAT THE DRIVER WAS SEATED IN THE DRIVER'S SEAT. I WAS HANDED THE DRIVER'S LICENSE. I OBSERVED THAT THE DRIVER HAD DIFFICULTY OPENING HER ZIPPERED COMPARTMENT, WHILE SHE WAS LOOKING FOR HER INSURANCE OR VEHICLE REGISTRATION. I THEN INFORMED JACQUELINE OF THE REASON I STOPPED HER.

WHILE I WAS SPEAKING WITH JACQUELINE, I NOTICED THAT SHE HAD THE OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM THEIR PERSON, AND AS SHE SPOKE TO ME IT BECAME STRONGER.

DRIVER'S STATEMENTS:

I THEN HAD JACQUELINE GET OUT OF THE VEHICLE. AS SHE DID THIS, SHE USED THE CAR DOOR FOR BALANCE AS SHE EXITED. I THEN HAD JACQUELINE WALK TOWARD ME, AND AWAY FROM THEIR VEHICLE. ONCE FINISHED TALKING WITH THEM, AWAY FROM THEIR VEHICLE, THE ODOR WAS STILL PREVALENT. I THEN ASKED JACQUELINE IF THEY WOULD BE WILLING TO DO SOME ROADSIDE TASKS TO MAKE SURE THEY WERE ABLE TO DRIVE. JACQUELINE STATED THAT THEY WOULD DO ROADSIDE TASKS. AT THAT TIME IT STARTED TO RAIN, AND IT BEGAN TO GET HEAVIER. I THEN ASKED JACQUELINE IF SHE WOULD BE WILLING TO MOVE TOWARD AN OVERHANG, WHICH WAS NEAR BY TO CONTINUE THE TASKS. SHE AGREED. SHE THEN RETURNED TO HER VEHICLE, BEGAN TO PUT HER HANDS ON THE WHEELS, BUT HAD DIFFICULTY LOCATING HER SUN ROOF SWITCH. SHE WAS ABLE TO LOCATE IT. JACQUELINE WAS THEN WALKED OVER TO MY VEHICLE, WHERE SHE SAT IN THE BACKSEAT OF THE VEHICLE, NOT IN HANDCUFFS, AND WAS DRIVEN OVER TO THE WELLINGTON MEDICAL CENTER OVERHANG THAT WAS VISIBLE FROM MY ORIGINAL LOCATION.

ONCE WE ARRIVED UNDER THE OVERHANG, JACQUELINE'S DOOR WAS IMMEDIATELY OPENED SO SHE COULD EXIT. I THEN WALKED HER TO THE FRONT OF THE VEHICLE, WHERE I CONDUCTED THE ROADSIDE TASKS.

ODORS:

OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM HIS PERSON, AND AS HE SPOKE TO ME IT BECAME STRONGER. ONCE I WAS SPEAKING WITH THEM, AWAY FROM THEIR VEHICLE, THE ODOR WAS STILL PREVALENT

Other Observations:

THE OVERHEAD FORWARD FACING BLUE POLICE LIGHTS WERE TURNED OFF PRIOR TO BEGINNING THE TASK. THEIR EYES TRACKED EQUALLY, THE PUPILS WERE THE SAME SIZE AND APPROPRIATE FOR THE LIGHTING CONDITIONS, AND NO HESITING NYSTAGMUS WAS OBSERVED. VERTICAL GAZE NYSTAGMUS WAS ADMINISTERED AND WAS OBSERVED. IT SHOULD BE NOTED THAT I HAD TO CONTINUALLY REMIND JACQUELINE NOT TO MOVE THEIR HEAD, AND TO FOLLOW THE STIMULUS, NOT LOOK PAST IT OR ANTICIPATE IT MOVING. I HAD TO HAVE HER HOLD HER CHIN TO PREVENT IT FROM MOVING.

WALK & TURN:

I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE WALK AND TURN TASK TO JACQUELINE WHO STATED THAT SHE UNDERSTOOD. JACQUELINE CHOSE TO REMOVE HER SHOES FOR THE TASK. DURING THE TASK I OBSERVED THAT JACQUELINE HAD THE FOLLOWING CUES: COULDN'T KEEP BALANCE WHILE LISTENING TO INSTRUCTIONS; STARTED TOO SOON; STOPS WALKING TO STEADY SELF/REGAIN BALANCE; MISSED HEEL-TO-TOE ON MAJORITY OF ALL STEPS; STEPPED OFF THE LINE ON THE MAJORITY OF ALL STEPS; USED ARMS FOR BALANCE RAISES ARMS OVER SIX INCHES; IMPROPER TURN (NOT AS INSTRUCTED TOOK ONE STEP NOT MULTIPLE); COULD NOT DO TASK (NOT A CLUE).

SHE WAS GIVEN TWO OPPORTUNITIES TO COMPLETE THE TASK, HOWEVER SHE WAS UNABLE TO COMPLETE IT.

ONE LEG STAND:

I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE ONE LEG STAND TASK TO JACQUELINE WHO STATED THAT SHE UNDERSTOOD. DURING THE TASK I OBSERVED THAT JACQUELINE HAD THE FOLLOWING CUES: SWAYED WHILE BALANCING; USED ARMS FOR BALANCE (RAISES ARMS OVER SIX INCHES); PUT FOOT DOWN (BEFORE 30 SECONDS); COULD NOT DO TASK (PUTS FOOT DOWN THREE TIMES). THE TASK WAS STOPPED FOR HER SAFETY, AS SHE NEARLY FELL MULTIPLE TIMES.

FINGER TO NOSE:

I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE FINGER TO NOSE TASK TO JACQUELINE. I EXPLAINED WHAT IS CONSIDERED THE TIP OF THE FINGER AND TIP OF THE NOSE TO JACQUELINE WHO STATED THAT SHE UNDERSTOOD. DURING THE TASK I OBSERVED THAT JACQUELINE HAD THE FOLLOWING CUES: FAILED TO RETURN ARMS TO THE SIDE; USED WRONG HAND FOR TASK (BY BRINGING IT MORE THAN HALF WAY UP).

THE TASK WAS CONDUCTED AS FOLLOWS: LEFT - PAD OF FINGER TO TIP OF NOSE AND REPEATED. SHE WAS REMINDED TO BRING HER HAND BACK DOWN AFTER TOUCHING TIP TO TIP. RIGHT - SEARCHED FOR HER NOSE, TOUCHED TIP TO LEFT SIDE OF NOSE. LEFT - PAD OF FINGER TO TIP OF NOSE. RIGHT - TIP OF FINGER TO TIP OF NOSE. RIGHT - BROUGHT LEFT HAND UP ABOUT HALF WAY, THEN BROUGHT RIGHT UP SEARCHED FOR TIP OF NOSE. LEFT - PAD OF FINGER TOUCHED LEFT SIDE OF NOSE.

ROMBERG ALPHABET:

PRIOR TO BEGINNING THE TASK, I CONFIRMED WHAT LEVEL OF EDUCATION JACQUELINE HAD COMPLETED. SHE STATED THAT THEY HAD A (level of education), AND IS FAMILIAR WITH THE ENGLISH ALPHABET. I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE ROMBERG WITH RECITATION TASK TO JACQUELINE WHO STATED THAT SHE UNDERSTOOD. DURING THE TASK I OBSERVED THAT JACQUELINE HAD THE FOLLOWING CUES: SWAYED MORE THAN TWO INCHES IN ANY DIRECTION.

THE MODIFIED ROMBERG BALANCE WAS EXPLAINED AND DEMONSTRATED TO JACQUELINE WHO STATED THAT SHE UNDERSTOOD. JACQUELINE WAS ASKED TO ESTIMATE THE PASSAGE OF 30 SECONDS IN THEIR HEAD. JACQUELINE SHOWED THE FOLLOWING CUES: SHE WAS SWAYING IN A CIRCULAR MOTION; SHE ESTIMATED 30 SECONDS AS 19 SECONDS.

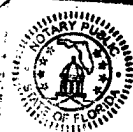

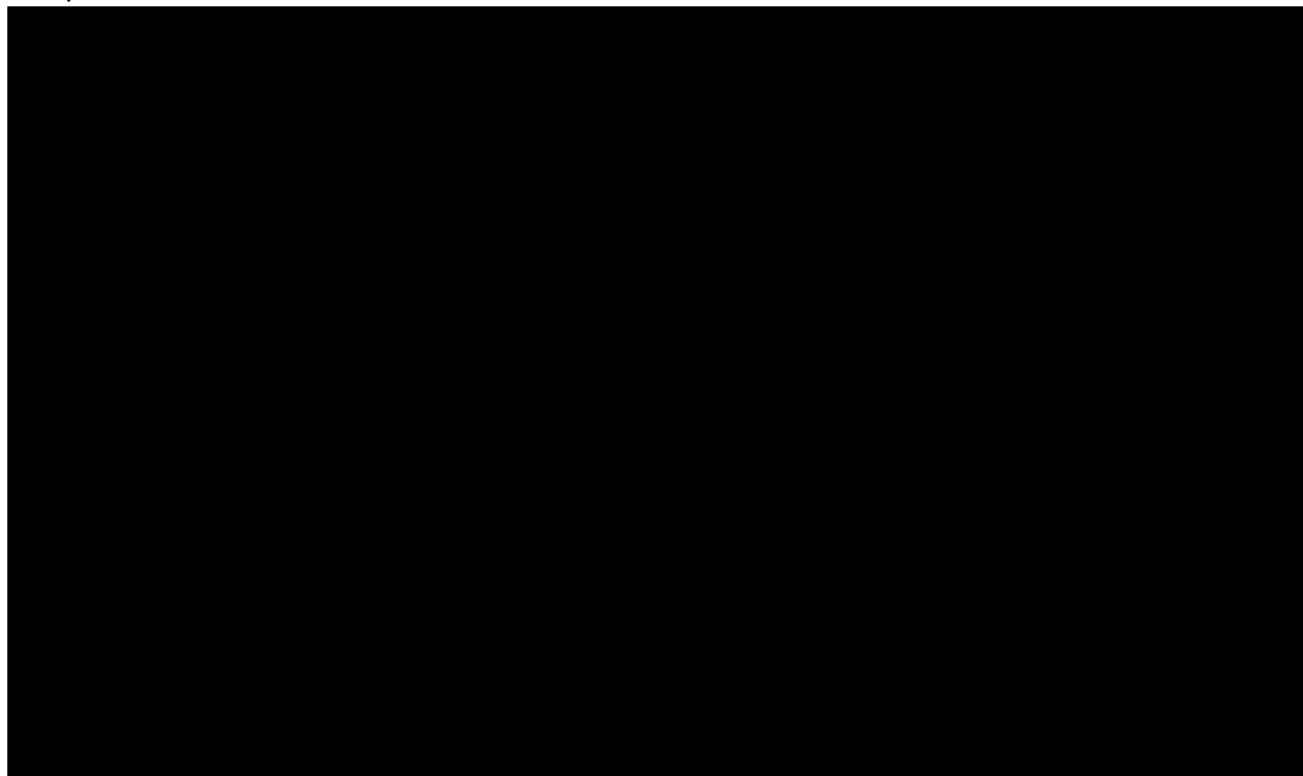
