


North Palm Beach, Florida reference a suspicious person who was climbing on a boat. On arrival, I made contact with the reporting party, Laura Ortman, who lives in apartment 301. Laura told me that an unknown white male climbed on her boat saying he didn't feel safe.</p> <p>We then made contact with the unknown white male who was all wet as if he just came out of the water. The unknown white male was identified as Jared C. Kripas (w/m 04/22/86) who lives at 412 Northlake Ct. apt 2. Kripas said he fell off the seawall in his back yard while walking his dog. While talking with Jared he had multiple abrasions on his arms and legs. Jared had the odor of an unknown alcoholic beverage emanating from breath as he spoke to me and Police Officers on scene. We asked Jared where his residence was and he replied "apartment 2". We then asked Jared to walk to the front of the apartment building to confirm his residence to avoid walking in the wrong residence from the rear which was not marked with apartment numbers.</p> <p>Jared refused our lawful commands and continued to walk into a residence via the rear porch which we did not confirm was his. Jared then attempted to pull away from Police Officer Mize from the door way and close it on him (see Police Officer Mize supplemental report). Jared was subsequently restrained, escorted to the ground, and put into handcuffs which were checked for tightness and double locked after a brief struggle on the ground. Jared sustained a minor abrasion on the head in the process of being placed in handcuffs. Jared passively resisted until he was in handcuffs by putting his hands under his chest refusing to bring them behind his back.</p> <p>Based on my investigation, probable cause exists to arrest Jared C. Kripas for resisting without violence contrary to F.S.S. 843.02 for disobeying lawful commands to confirm his residence and walking into an unknown residence to which we stopped him from doing</p>

Once cleared from the hospital, he was transported to the Palm Beach County Jail without incident.
