


Upon arrival I made contact with the following parties involved. Jared Lamar (boyfriend), Maria Nitti (girlfriend/mother), Elana Nitti (daughter), [REDACTED], Micah Geraci (friend), and Johnathan Olive-Blanco (friend).</p> <p>I met with Jared Lamar separately first. Jared advised that Maria's daughter, Elana, invited her friends, [REDACTED], Micah, and Jonathan over to the house. Jared did not want Elana's friends over the house so he told them they had to leave. Jared walked over to the Elana's bedroom where Elana and her friends were at and opened the door and told them to leave. Jared said [REDACTED] got in his face and threw a punch at him. Jared said [REDACTED] missed and he threw [REDACTED] down the stairs.</p> <p>I spoke with Elana Nitti separately. Elana said her mother, Maria, said it was ok if she brought three of her friends over. Maria said it was ok, but to go to her room right when she comes over because Jared was intoxicated. Elana said Jared broke the door to her room and Jared forced her outside and she walked down the stairs to the parking lot herself. While she was outside she thought her friends followed, but quickly realized they were still inside. Elana ran back inside and saw Jared on top of her friend, [REDACTED] at the bottom of the stairs..</p> <p>I spoke to [REDACTED] separately. [REDACTED] advised he arrived at Elana's house between 2100-2130 hours. [REDACTED] said before they arrived Maria told Elana to go straight to the room with her friends and lock the door because Jared was intoxicated. While they were in the room they heard arguing between Maria and Jared. [REDACTED] said between all the yelling at one point Jared kicked down the door to the bedroom and broke it. | <p>everyone in the room stood up in fear. As Jared entered Jared was yelling [REDACTED] said to Jared "sir please" and Jared pointed at [REDACTED] and yells "Get the fuck out of my house." [REDACTED] said he was leaving and Maria told him to stay until the police came so he could be a witness to the argument between Maria and Jared prior. [REDACTED] said he went to the living room where Maria told him to take a seat and then Jared began to yell again telling Micah, Johnathan and [REDACTED] to leave. [REDACTED] said no sir we aren't leaving because Maria wanted them to stay. Jared replied "What?" and charged at him and wrapped his arms around him like a "bear hug" and dragged him to the stairs. When they got to the house Jared turned off the A/C and the power to the house. Micah said all her friends went into the Elana's bedroom. Micah said at some point Jared broke the door to Elana's bedroom. Micah said Maria told them to sit on the couch and wait for the police. Micah said before they could sit Jared came over to [REDACTED] and grabbed [REDACTED] by the arm and started to push him forcibly down the stairs. During the altercation [REDACTED] and Jared tumbled down the stairs. I asked Micah to describe the altercation in greater detail, but she advised it all happened to fast and it was sort of a blur.</p> | | | | | | | | |
| S T A T E M E N T | <p>I spoke with Jonathan separately. Jonathan said his friends and him went over to Elana's house because Maria said it was ok for them to come over. When they got to Elana's house they went right to Elana's room. Not too long after when they were in the bedroom they heard Maria and Jared arguing. Jonathan said Jared came to Elana's door and began to bang on it telling them they had to leave. Maria told Jonathan, Micah, [REDACTED] to stay because she wanted them to be witnesses to the argument that was happening prior to him banging on the door. Jonathan said Jared broke the door down and came into Elana's room yelling. Maria put herself in between Jared and Jonathan and his friends to protect them. Jonathan said Elana tried to talk to Maria, but Jared forced her outside. They all exited the room and Maria told Jonathan, [REDACTED], and Micah to sit on the couch and wait for the police. Before they could sit on the couch Jared came at [REDACTED] and wrapped his arms around [REDACTED] in a "bear hug."
