

On the 09 day of September 20 17 at 0840 A.M. P.M. (Specifically include facts constituting cause for arrest.)


September 09, 2017 at approximately 0840 hours while on routine patrol in the closed business located at 3044 S. Military Trl in the unincorporated area of West Palm Beach, Palm Beach county in preparation for hurricane Irma I saw two white females later identified as _____ and Jasmin Arroliga 10/21/93 kneeling down in the stairwell located on the eastside of the building. I saw that Mrs. Arroliga with a needle in her hand getting ready to inject something into _____ left arm. When I began to approach the two females Mrs. Arroliga dropped the needle and the plastic cap she had in her hand onto the steps. _____ dropped a clear baggy from her left hand onto the ground and attempted to conceal it with her left foot. I retrieved all the above mentioned items which both female admitted that they contained heroin. On the ground next to where Mrs. Arroliga was sitting prior to me pulling up was a multi colored purse which Mrs. Arroliga admitted was her. In plain view inside this purse which was open was several small clear baggies with two of them still containing suspected heroin.

While waiting for additional unit to arrive I observed _____ attempting to conceal something in her bra area. When I question _____ what she had she stated a Hydrocodone pill. D/S Izzarone arrived on scene and recovered the pill which was in a clear baggy with marking PR/30. I field tested all the suspected heroin with a Sirchie test kit which had negative results I attempted to identify the pill with the Drug Identification Bible and the Internet which had negative result. All the aforementioned items were placed into evidence for further processing and both females where released at the scene pending results from crime lab.

October 12, 2017 I received a chemistry report from Senior Forensic Scientist Diana Lawrence with the results in this case. The report states that Sub #002-01 contained Heroin Schedule I and Fentanyl Schedule II net weight .0187 grams and Sub #00202 was Oxycodone Schedule II.
