Dispatch informed units responding. A white male wearing blue shirt and tan shorts took Milwaukee Tools over \$300 worth and is walking toward the Polo Tropical in the parking lot with merchandise. Subject got into a blue Chevy Malibu tag 246TFC and head North on Milby Trail. Vehicle was seen at 10th Ave and Kirk Rd. heading eastbound by Sgt. Collura matched the description and tag number. Vehicle was stopped. 3 subjects were inside the vehicle including the white male wearing a blue shirt and tan shorts. Upon arrival at the store I proceeded to make contact with Loss Prevention Witness Alexander Zelmick and Shaun Kirk who got in to my patrol vehicle to do a show up. Both Alexander and Kirk positively identified the white male in blue shirt and tan shorts who was later identified as Jason Khalil Ghannoun DOB 7/2/80. Lt Zelmick and Kirk stated def. Ghannoun enter the hardware department with an empty cart. They continued to observe the defendant and he selected two Milwaukee Combo Kits valued @ \$399.00 each and place them in the shopping cart. Defendant then pushed the cart toward contractor exit door. The defendant pushed the cart passed all points of sale without rendering payment for the items in question. Zelmick and Kirk followed Ghannoun across the parking lot while he pushed cart to a blue Chevy Malibu parked at Polo Tropical. Ghannoun loaded the two Milwaukee Combo Kit into the car and the car drove off. Kirk stated he heard the female drive yell "go, go" and Ghannoun jumped in the passenger seat. Vehicle drove through the parking lot and headed North on Milby Trail. Total Stolen Record in the trunk of car Ghannoun was TOT \$305.</p>
