Narrative:

On January 7, 2018 at approximately 2124 hours, I was dispatched to 512 NW 24th Ave, Boynton Beach, Florida in reference to a Domestic. It was advised by BBPD Communications Personnel that B/M, Barron Jordon (D.O.B 03/08/1976) reported being shot with a Taser 3-4 times by his boyfriend later identified as W/M, Jason Michael Tomaselli (D.O.B 12/21/1986). For documentation purposes, Jordon and Tomaselli have been in a relationship for approximately (8) months and reside at the above address as a family unit. On arrival to the above stated address, I made contact with Tomaselli who was home alone and provided the following statement captured on my department issued Body Worn Camera. Tomaselli advised that earlier in the evening, he confronted Jordon in regards to relationship issues where the argument became heated. Tomaselli stated Jordon pulled a Taser and turned it on: however, not activating it. Tomaselli advised he then made advances towards Jordon where a struggle ensued, causing both subjects to wrestle on the ground. Tomaselli provided multiple conflicting statements advising he was shot with the Taser by Jordon then stating he was not. Tomaselli also made statements advising he was in possession of the Taser. No injuries were observed on Tomaselli's person which would lead me to believe he was the victim of Taser related injuries or physical strikes from Jordon.

Jordon later returned to the residence and provided a sworn statement captured via Body Worn Camera. Jordon advised that earlier in the day he was involved in an argument with Tomaselli which was due to past issues with infidelity. As a result of the argument he locked himself in his room and to avoid Tomaselli. Jordon advised that Tomaselli later returned with a Taser and pointed it in his face. Jordon advised that Tomaselli shot the Taser in his direction as he advanced forward to continue striking him with the Taser multiple times. Jordan stated he placed his arms up to protect himself before both subjects fell to the ground. Jordon advised that as he was on the ground he made no attempt to bring harm to Tomaselli. As a result of Jordon falling to the ground from Tomaselli's aggressive advances, Jordon sustained multiple abrasions to his (R) shin, (R) outter forearm (R) outter bicep. Medical attention was offered to Jordon however he refused treatment.

Based on the fact that Tomaselli stated he made advances towards Jordon which led to the two wrestling causing Jordon's injuries, Tomaselli is believed to be the primary aggressor. Tomaselli was arrested for (1) count of Domestic Battery per F.S.S 784.03.1A1. Tomaselli was handcuffed D/L (Checked for proper spacing) and transported to BBPD for processing. Tomaselli was later transported to Palm Beach County Jail without incident.
