

Northcom dispatch advised me that the suspect was a white male with dark hair wearing a blue football jersey, and was last seen walking east on Michael street towards Marrian Ave.</p> <p>Upon my arrival in the area, I located a White male with dark hair, wearing a blue football jersey walking east on Michael St. about to cross Marrian Ave. I made contact with the individual later identified as Jason Corrigan (W/M 09-04-75), and placed him in protective custody due to him matching the description of the suspect. I placed him into handcuffs, checked for proper spacing and double locked them. I observed lacerations on his right knuckles; he was sweating through his shirt and both of his palms were dirty and he seemed extremely confused and intoxicated.</p> <p>The complainant, Genaro Martinez De Villa (W/M 1-21-66) was escorted by Sergeant Alexandre to the corner of Michael St. and Marrian Ave. to conduct a show up and he positively identified Corrigan as the suspect that was in his yard and banging on his door.</p> <p>Martinez De Villa advised the following: His dog began barking toward the window on the east side of his residence, he went over to a window on that side and closed the curtain thinking it was an animal that his dog may have seen. He then noticed his dog continuing to bark and he went to his front door to close those blinds. As he approached the front door, he observed a white male wearing a blue football jersey on his doorstep. Martinez De Villa advised that he banged on the door to try and get the subject to leave his property as he was not known to him nor was he invited there. At that point, Corrigan raised his arms in the air and walked away towards the east side of</p>

his residence. Martinez De Villa then walked outside and observed his wooden fence gate area destroyed with boards broken and lying on the ground. He advised that he would prosecute for trespassing and criminal mischief. I photographed the damage to the fence.


Based upon my above investigation, I found probable cause to place Jason Corrigan under arrest for Trespass on a property other than structure as Corrigan did, without being authorized, licensed, or invited willfully enter upon or remain in any property other than a structure or conveyance the property of Genaro Martinez De Villa, as to which notice against entering or remaining was given, either by actual communication or by posting, or fencing or cultivation as described in 810.011, {or} said property was the unenclosed curtilage of a dwelling and Jason Corrigan entered or remained with the intent to commit an offense thereon, other than the offense of trespass, contrary to Florida Statute 810.09(1)(a) and (2)(a) and for Criminal Mischief Breaking Or Injuring Fences as Jason Corrigan did willfully and maliciously break down, mar, injure, deface, cut, or otherwise create or cause to be created an opening, gap, interruption, or break in any fence, or any part thereof, belonging to or enclosing land not his own, or did cause to be broken down, marred, injured, defaced, or cut any fence belonging to or enclosing land not his own, contrary to Florida Statute 810.115(1).

I read Corrigan Miranda Warnings and he advised that he understood his rights and was willing to talk to me without a lawyer present. Corrigan advised the following: He remembered being at a friend's house on Foster St. (which is approximately four blocks down from where the incident occurred) and then he remembers being placed into handcuffs, but does not recall anything in between. I photographed both of Corrigan's hands.

I transported Corrigan to Jupiter Medical Center to be medically cleared due to the lacerations on his knuckles and him complaining of non-related abdominal injury. After being medically cleared, Corrigan was subsequently transported to Palm Beach County Jail, on Gun Club Road without incident.

I submitted the photographs of the damaged fence and of Corrigan's hands to Jupiter Police Evidence. I utilized my Body Worn Camera for all statement's made during the call for service.
