## PROBABLE CAUSE

On November 14, 2016 at approximately 2241 hours, I (Officer Scaduto) and Corporal Yildiz assisted Sergeant Kozak on a traffic stop where he was conducting a DUI investigation (TPD case #16-384). During the traffic stop, the passenger (later identified via Florida Driver's License as Jasper Oquendo) called 911 which was routed to Northcomm. Oquendo complained to Northcomm that the Officers on the traffic stop were giving his girlfriend a hard time. Northcomm transferred the call to Martin County Sheriff's Office because subject thought he was in Hobe Sound, FL. Martin County Sheriff's Office transferred his call to Tequesta Police Department at 2245 hours where Oquendo spoke to dispatcher Anderson #1185 to continue his complaints. At 2302 hours Oquendo called 911 a second which again was routed to Northcomm where he spoke to dispatcher Garcia #434 complaining about the officers.

At no time did Oquendo use 911 for any emergency purposes, but only to complain about the traffic stop.

I placed Oquendo under arrest for misuse of 911. While transporting Oquendo to Tequesta Police holding cells to complete my paperwork, he advised me that as an American citizen he has right to use the non-emergency 911 to ask questions and make complaints.

Based on my investigation, I have reason to believe that probable cause exists and that the defendant did unlawfully and knowingly access the 911 for the purpose of making a complaint of a non-emergency nature contrary to FSS 365.172(13).
