	On the 15 day of April , 2017 at 04:47 (Specifically include facts constituting cause for arrest.)									
	On 04/15/17 at approximately 0407 hours, while conducting routine patrol, I observed a silver Audi (FL tag GTJM30) fail to stop at a flashing red light at the intersection of NW 19th Street and NW Renaissance Way. The Audi continued northbound towards Glades Road then turned westbound on Glades Road. I initiated a traffic stop and we made our final stop in the parking lot of 2301 W Glades Road.									
	I approached the vehicle and observed a W/M, later identified by his FL DL as Jean Sarmiento, in the driver seat. I immediately smelled the odor of marijuana emanating from the interior of the vehicle; I requested back-up units and Sergeant Dubinsky and Officer Tyson arrived on scene.									
	I searched the interior of the vehicle and discovered an orange powdery substance inside of a clear container in the center console. The center console also had a D-Amphetamine Salt Combo 20mg prescription bottle prescribed to Sarmiento. Inside of the prescription bottle were several orange pills and two multi-colored pills labeled "1 THC". I contacted poison control and spoke to operator Michael Hasyn (ID#106190) who advised that the orange pills were Amphetamine's 20mg. I described the multi-colored pills to Hasyn and he was unable to identify them (Case# M-3561586).									
	I read Sarmiento his Constitutional Rights from a pre-printed department issued Miranda card. Sarmiento stated he understood his rights and wished to speak to me. I showed Sarmiento the items I found in the center console and he stated that it all belonged to him. Sarmiento stated that the orange powdery substance was marijuana and that he sprinkles it on regular marijuana to get a better high. Sarmiento also stated that the two multi-colored pills were marijuana in pill form.									
	I tested the orange substance and the multi-colored pills using two separate department issued Quick Check Test Kits (one use only). The tests were positive by turning purple.
