On the 9th day of March 20 18 at 8:52 A.M P.M (Specifically include facts constituting cause for arrest.)

On 03.09.18 at approximately 2052 hours, I was dispatched to the area of 2nd Ave South/SOUTH DIXIE Hwy in the City Of Lake Worth in reference to a white Mercedes Benz bearing FL tag # H8DL62. According to the complainant, the white Mercedes Benz was hitting curbs, and the unknown female driver, described as having blonde hair, continuously keeps closing her eyes while driving. While on route, the complainant advised that the Mercedes Benz was currently heading NB on North Dixie Hwy approaching 3rd Ave North. At this moment, I got visual of the Mercedes Benz where I then began to keep of eye on it for driving patterns. While keeping an eye of the vehicle in question, I observed the vehicle (Mercedes Benz) swerving from lane one to lane two. The vehicle was unable to maintain a single lane which caused a black small vehicle to swerve in attempt to avoid a collision. Due to the heavy vehicle traffic on North Dixie Hwy, the Mercedes Benz unable to maintain a single lane and almost causing a collision, I activated my emergency lights (red and blue lights) to conduct a traffic stop. The Mercedes-Benz came into a complete stop at the 1300 Block Of North Dixie Hwy. I made contact with the driver who was the sole occupant of the vehicle, who identified herself as Jean A. Jones-Testa.

Mrs. Jones-Testa had glassy eyes, slurred speech, and I was able to smell the odor of an unknown alcoholic beverage coming from her breath. I asked her where she was prior to me stopping her and she stated she was at a restaurant having dinner however, she could not tell me that name of the restaurant. I then asked her if there was a reason for her not to be able to maintain a lane and she said no. I lastly asked her if she had any medical problems and she said no.

D/S J. Schneider from the DUI unit, responded to the scene shortly after where he conducted a DUI investigation.

This concludes my involvement in this case.

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

A 911 call was placed to PBSO communications by a Benny Figerola (847) 732-3170 due to a white Mercedes traveling approximately 20 miles per hour north on Dixie Highway that continued to strike the curb and swerve. PBSO units were dispatched at which time Deputy Monroy #12463 came behind the vehicle and made the same observations. Due to her observations she activated her emergency lights to pull the vehicle over. Her observations were documented in a supplemental probable cause affidavit.

OBSERVATION OF DRIVER:

On my arrival I found a white female sitting in the driver seat of the white Mercedes. She was the sole occupant of the vehicle and I found the registration was in her name. Upon speaking to the driver I observed she had thick slurred speech and the odor of a unknown alcoholic beverage coming from her person and breath. Also while speaking with her I observed her eyes to be red, bloodshot, glossy and her eyelids droopy. Her movements were slow and lethargic upon returning her registration and insurance and she seemed to have poor dexterity dropping her registration to the floorboard of the passenger seat.

I dont have any medical problems. I don;t have any head injuries. I was coming from a restaurant.

Other Observations:

Onset of nystagmus was at approximately 35 degrees. Testa had extreme difficulty in standing swaying heavily and stumbling numerous times. She had to be reminded numerous times to follow the stimulus with her eyes and not turn her head.

WALK & TURN:

Testa was unable to stand in the instructional position. She had to have the stance both explained and demonstrated numerous times and was ultimately unable to maintain the instructional stance. After abandoning my attempts to have her positioned properly I explained the task. She confirmed she understood it and upon starting to walk she failed to touch heel to toe at any point. She also failed to stay on the line, took too many steps, and failed to count out loud as instructed. She performed a improper turn, failed to touch heel to toe on her way back and failed to stay on the line. She insisted on keeping her heels on during this task.

ONE LEG STAND:

Testa stumbled while standing in the instructional position and swayed heavily. She confirmed she understood the task and upon starting if lifted her foot improperly. As her foot went down she proclaimed she was unable to do this because her foot was too heavy at which time she stopped the task. During this task she insisted on keeping her heels on.

FINGER TO NOSE:

Testa stumbled while standing in the instructional position and swayed heavily. After I demonstrated this task and she confirmed she understood it was started. Immediately upon tilting her head back she stumbled forward onto the hood of my car. Attempting to tilt her head back and close her eyes again she again stumbled therefore I stopped this task for her safety.


