I RESPONDED TO THE AREA OF FOREST HILL BLVD AND S STATE ROAD 7 WELLINGTON, FL 33414 REFERENCE TO A POSSIBLE DRUNK DRIVER COMPLAINT. UPON ARRIVAL, I OBSERVED THE SUSPECT VEHICLE A RED 2008 MINI-COOPER FOUR DOOR BEARING FLORIDA TAG GDFH56 TRAVELING SOUTHBOUND ON S STATE ROAD 7 THROUGH FOREST HILL BLVD. SGT. R. THAETER #5362 AND I CONDUCTED A TRAFFIC STOP ON THE VEHICLE AT S STATE ROAD 7 AND HUTTON BLVD DUE TO THE FRONT DRIVER SIDE HEAD LAMP BEING OUT. SGT. THAETER MADE CONTACT WITH THE DRIVER AND SOLE OCCUPANT WHO WAS POSITIVELY IDENTIFIED AS JEANNIE R. COURTRIGHT (W/F 05/03/72) BY HER FLORIDA DRIVER'S LICENSE. WHILE SPEAKING WITH COURTRIGHT SHE SEEMED VERY LETHARGIC. COURTRIGHT STATED THAT SHE HAD ONLY SLEPT FOR FOUR HOURS FOR THE LAST TWO NIGHTS. SGT. THAETER ASKED COURTRIGHT IF THERE WAS ANYTHING ILLEGAL IN THE VEHICLE AND COURTRIGHT STATED THAT THERE WAS NOTHING ILLEGAL IN THE VEHICLE. SGT. THAETER ASKED IF WE COULD SEARCH THE VEHICLE FOR ILLEGAL CONTRABAND AT WHICH TIME COURTRIGHT GAVE VERBAL PERMISSION TO SEARCH THE VEHICLE. SGT. THAETER BEGAN SEARCHING THE VEHICLE AND DISCOVERED A CLEAR GLASS PIPE CONTAINING WHITE RESIDUE WHICH THROUGH MY TRAINING AND EXPERIENCE IS KNOWN TO SMOKE CRACK COCAINE LOCATED IN THE CENTER CONSOLE. SGT. THAETER ASKED COURTRIGHT IF SHE KNEW THE PIPE WAS IN THE CENTER CONSOLE AND SHE ADMITTED THAT SHE KNEW THE PIPE WAS THERE.

AT THIS TIME, I BEGAN SEARCHING THE VEHICLE AND DISCOVERED A WHITE RECTANGULAR PIECE CRACK WHICH THROUGH MY TRAINING AND EXPERIENCE IS KNOWN TO ME AS CRACK COCAINE LOCATED ON THE FLOOR BOARD BETWEEN THE DRIVER'S SEAT AND THE DRIVER'S DOOR. I ALSO DISCOVERED A GREEN LEAFY SUBSTANCE WHICH IS KNOWN TO ME AS MARIJUANA IN A TAN BEBE MAKEUP CASE LOCATED IN COURTRIGHT'S PURSE WHICH WAS ON THE PASSENGER SEAT OF THE VEHICLE. THE CRACK COCAINE WAS FIELD TEST POSITIVE AS COCAINE BY A DEPARTMENT ISSUED COBALT KIT AND FIELD TEST NEGATIVE BY A DEPARTMENT ISSUED MARQUIS KIT. THE MARIJUANA WAS FIELD TEST POSITIVE FOR THC BY A DEPARTMENT ISSUED DUQUENOIS KIT.

AT THIS TIME, COURTRIGHT WAS ARRESTED WITHOUT INCIDENT AND CHARGED WITH POSSESSION OF A CONTROLLED SUBSTANCE (CRACK COCAINE), POSSESSION OF MARIJUANA UNDER 20 GRAMS, AND POSSESSION OF DRUG PARAPHERNALIA (CRACK COCAINE PIPE). SHE WAS HANDCUFFED (DOUBLE LOCKED AND CHECKED FOR FIT) AND PROCESSED. SHE WAS LATER TRANSPORTED TO THE PALM BEACH COUNTY JAIL. NOTHING FURTHER.
