On the above date and time I responded to 17168 Cassava Way in unincorporated Boca Raton in reference to domestic incident in progress. Upon arrival I met with the complainant Jon Lobbe who stated that his stepson Jeffery Westerfield struck him in the face with an open hand. Jon stated that Jeffery was under the influence of alcohol and he asked him to go to his room and go to sleep. Jon stated that he was argumentative and it began to escalate. Jon stated that during the altercation Jeffery slapped him on the left side of his face. Jon then asked his wife Jackie Westerfield to call 911. I observed a red mark on the left side of Jon's face. I then spoke with Jeffery who smelled of alcohol and was slurring his words. I asked Jeffery what happened and he stated that he Jon were arguing and things got out of hand. Jeffery stated that during the altercation he slapped Jon in the face with an open hand. Jeffery could not recall which hand he struck Jon with. Jeffery further stated that he Jon did not strike him back in retaliation. Based on the above facts and investigation I found probable cause to arrest the defendant Jeffery Westerfield for domestic battery which is a violation of F.S. 784.04(1A1). Sworn statements were taken from Jon and pictures of the scene and victim were submitted to evidence. Jeffery was transported to county jail without incident.
