On August 15, 2017, your Affiant was assigned the investigation of a Cyber Tipline received from the National Center of Missing and Exploited Children (NCMEC) which was forwarded from the Broward County Sheriff's Office, South Florida ICAC Task Force.

On August 1, 2017, an electronic service provider reported 4 videos of child pornography had been uploaded to their site. These images were uploaded to their site between the dates of March 8th and April 28th, 2017. The resulting investigation determined the IP address provided by the electronic service provider was owned by Comcast. Your affiant requested the Palm Beach County State Attorney's Office issue a subpoena for the customer assigned the IP address at the time the images were uploaded.

On August 18, 2017, Comcast reported the contraband images were transmitted from the IP address in question which is assigned to customer Jeff Bowdoin, located at 4200 Community Dr., Apt 411, West Palm Beach, FL. Florida Department of Motor Vehicle records confirmed Jeffrey Bowdoin current address as 4200 Community Dr., Apt 411, West Palm Beach, Florida.

On November 7, 2017, based on an affidavit describing the above facts the Honorable Judge Janis Keyser granted the issuance of a search warrant for the residence of 4200 Community Dr., Apt 411, West Palm Beach, Florida.

On the morning of November 9, 2017, the search warrant was executed by the West Palm Beach Police Department and members of the ICAC (Internet Crimes against Children) task force. Upon entering Jeffrey Bowdoin was located in the residence in his bedroom. During a post Miranda interview, Jeffrey admitted that he owned a LG cellular telephone which was located in his bedroom as well as a Capital One credit card. Jeffrey then stated child pornography "popped up" in Tumblr. During a search of the residence, one black/silver LG cell phone was discovered hidden in a black satin pillow case on his bed as well as the Capital One credit card used to purchase the electronic service provider which contained the child pornography. Documentation linking Jeffrey to the electronic service provider was also seized from his residence.

On the same date, a forensic examination of the electronic devices recovered from Jeffrey Bowdoin's residence was conducted by members of the Palm Beach County Digital Forensics Task Force. These examinations were met with positive results in the recovery of 1 video of child pornography. This video depicted a naked prepubescent child engaging in sexual conduct as well excess images of child erotica. An application for the



Based on the fact that Jeffrey had an application downloaded and located on his cellular telephone and documentation seized from within his residence that linked him to, and matched the electronic service provider who initially reported the 4 videos of child pornography, along with the 1 video located on his cellular telephone on scene, I find probable cause exists to arrest Jeffrey Bowdoin and charge him with 5 counts of possession of Child Pornography FSS 827.071(5).
