On 09/23/2019 at approximately 2353 hours, I was on patrol in my marked green and white Palm Beach County sheriff's office vehicle when I observed a white male walking around in the median of North Dixie Highway in the 100 block of North Dixie Highway, City of Lake Worth Beach, Palm Beach County, Florida. As I approached the male, he sat down in the grass of the median. I stopped my patrol vehicle on North Dixie Highway facing north and activated my overhead lights, approached the male and made contact with him. The male verbally identified himself as Jeffrey Daniel Denger (05/04/1987).

A records check with PBSO dispatch returned a warrant out of Brevard County for Violation of Parole with full extradition.

I asked Mr. Denger to step toward me and he ran east across Dixie Highway, circled and attempted to run west bound when he was tackled by D/S Goodman, ID# 26786 (see supplement) who restrained Mr. Denger while I applied handcuffs which were checked for proper fit and double locked.

In addition to the warrant, Mr. Denger is charged with Resisting Arrest without Violence in violation of FSS 943.02 for attempting to run away from law enforcement in the commission of lawful duties.
