On October 5th, 2019 at approximately 2249hrs while on routine traffic control in my marked vehicle, I observed a white ford truck bearing FL Tag#Z46HND driving at a high rate of speed, eastbound on Okeechobee Blvd approaching State Rd 7, in the Village of Royal Palm Beach, FL, 33411. I paced the vehicle in my marked unit VIN#1FAHP2MKXFG119458 (asset #70057) driving seventy miles per hour in a posted fifty mile per hour zone. I initiated the traffic stop at Okeechobee Blvd and State Rd 7 and the vehicle came to a final stop at Okeechobee Blvd and Baywinds Blvd. I made a passenger side approach where I made contact with the driver and sole occupant of the vehicle as Jeffrey Dapkus DOB: 05/05/1980. I explained my reason for the stop and asked Dapkus for his license, registration, and proof of insurance to which he complied.

After running a records check through dispatch, it became apparent that Dapkus was driving with a suspended license as of 08/15/2019 for Failure to Pay Traffic Fine. This information was verified by myself through DAVID. Per DAVID it shows that Dapkus received the notice of suspension on 07/26/2019.

Based on the above facts I have probable cause to charge Jeffrey Dapkus with one (1) count of driving while license suspended with knowledge pursuant FSS 322.34 (2). Dapkus acknowledge receipt of the notice with his signature and right thumb print.

During this encounter with Dapkus DUI Investigator Lynch #8568 was called to perform Field Sobriety Tasks (reference CN#19-123115). Dapkus was also placed under arrest for driving under the influence. Dapkus was turned over to Investigator Lynch where he transported him to the main detention center for further testing.

This case is cleared by Arrest.
