



On the above date and time I responded to 7841 Afton Villa Ct. Boca Raton, FL. 33433. The nature of this call was a domestic battery that just occurred. Ashley Foster was present outside at the above address and appeared to be upset. Ashley told me her husband Jeffrey Foster showed up at her residence for visitation with their son. Both subjects were in a verbal disagreement and Ashley grabbed her cell phone and started to record Jeffrey. Jeffrey then grabbed Ashley cell phone to prevent Ashley from recording him. Ashley made an attempt to retrieve her cell phone from Jeffrey and Jeffrey pushed Ashley in the collar bone area; causing Ashley to fall to the ground. Ashley said she left the residence and called the police.

I then made contact with Jeffrey who told me he was upset with Ashley because she had another man sleeping at the house while his son was present. Both subjects were in a verbal disagreement and Ashley started to record him without his permission. Jeffrey said he took the phone in order to delete the recording. Ashley then went towards him and Jeffrey placed both hands up to prevent Ashley from charging him.

Based on my investigation, it appeared a physical altercation occurred between Jeffrey Foster and Ashley Foster. The Defendant Jeffrey Foster was handcuffed, handcuffs were double-locked, and handcuffs were checked for tightness. The defendant Jeffrey Foster is charged with Simple Battery pursuant to F.S. 784.03(1)(A)(1).
