[REDACTED] stated between 1930 hours and 2015 hours on 04/21/2017 while eating dinner (which she provided a receipt) at 499 East Palmetto (Trattoria Romana), located in Boca Raton, Florida, she was confronted by [REDACTED] (Jeffery Levin).</p> <p>[REDACTED] has a non-expiring protection order against Levin (140485659) which was issued by the Broward County Sheriff's Office on 07/09/2014 (final served on 07/24/14). This order was confirmed in place by Boca Raton Police Dispatch.</p> <p>According to [REDACTED] she arrived at Trattoria Romana at approximately 1800 hours where she sat at the bar with friends from work. [REDACTED] then noticed Levin sitting behind her while she was at the bar at approximately 1930 hours. [REDACTED] stated she did not contact the police because she was embarrassed and did not want to cause a scene in front of her friends.</p> <p>After finishing dinner and paying the check, she walked out of the front door of the restaurant. While walking out of restaurant, Levin followed her and confronted [REDACTED] at the exterior entrance to the restaurant. [REDACTED] stated to Levin, "you can't be near me, I have a no-contact order." Levin then replied, "it was only temporary you fucking cunt."</p> <p>[REDACTED] then went to her vehicle and left the scene.</p> <p>On 04/22/2017 at approximately 1300 hours, Officer Buckheit contacted Levin via his cellular telephone number (561-809-5333). Officer Buickheit informed Levin the protection order was permanent and he was served with this order on 07/24/2014. Officer Buckehit requested Levin to come to the Boca Raton Police Department to give a statement, Levin declined meeting in person and stated "I am not gonna come to the Police Department, why so you can arrest me."</p> <p>Based on my investigation, Levin knowingly confronted [REDACTED] (protected party) against her will while she waited for her vehicle, contrary to F.S.S. 784.0487(4a).</p> <p>I request a warrant issued for Levin's arrest.</p>
