#### PROBABLE CAUSE

On 4/29/18 at approximately 1711 hours I, Officer Nathan Brock, Officer Heather Grant and, Investigator Brian Coffin, of the Florida Fish and Wildlife Conservation Commission was on patrol on the ICW in Southern Palm Beach County. I observed a small vessel Southbound with five people on board. The vessel had too much weight in the bow and was taking water over the front from boat wakes. I initiated a vessel stop on the vessel to conduct a boating safety inspection and to tell the operator to move some weight to the back of the vessel. Once along side Officer Grant started a boating safety inspection. The vessel did not have enough life jackets on board. I observed a bunch of beer cans and bottles on the bottom of the boat. The operator of the vessel had slurred speech and would repeat his questions asked to Officer Grant. His movements were also slow and lethargic. Officer Grant asked the operator how much he had to drink. He said that he had three beers. Officer Grant also asked when he consumed the last alcoholic beverage. He said it was forty-five minutes before. Officer Grant asked the subject for his name and date of birth. He identified himself as Jeffery W. Everhart, DOB 5/22/69. I approached Everhart and asked if he would do a field sobriety task for me. He said that he would. I assisted Everhart with stepping across onto my vessel. As I walked behind Everhart I could smell the odor of an alcoholic beverage coming from his person. I set him on the step in the bow of my vessel.

The first field sobriety task I conducted on Everhart was HGN. During HGN he exhibited six scientifically validated clues. Lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to forty-five degrees were all present in each eye. He also had vertical nystagmus. The initial angle of onset when checking onset prior to forty-five degrees was thirty-degrees.

The second scientifically validated exercise I conducted on Everhart was Finger to Nose. During finger to nose he exhibited thirteen scientifically validated clues. The third scientifically validated exercise I conducted on Everhart was Palm Pat. During palm pat he exhibited six scientifically validated clues. The final scientifically validated exercise I conducted on Everhart was Hand Coordination. During hand coordination he exhibited six scientifically validated clues.

I then told Everhart he was under arrest for boating under the influence and read to him the Florida Implied Consent Warning for vessels. Everhart agreed to provide a breath sample. I setup my Intoxilyzer 8000 and then started the twenty minute observation period. It began at 1749 hours. At 1809 hours I started entering information into the Intoxilyzer 8000. At 1815 hours Everhart provided a breath sample of 0.204 grams per 210 liters of breath. At 1818 hours he provided the second breath sample of 0.203 grams per 210 liters of breath.

Everhart's vessel was released to someone else on board that was sober. We then transported him to Silver Palms Boat Ramp. Custody of Everhart was transferred to Boca Police Department who transported him to Palm Beach County Jail.
