I responded to [Redacted] Palm Beach County, Florida 33417 in reference to a domestic dispute in progress.

Upon my arrival at the residence, I made contact with [Redacted] (W/F, DOB 11/04/2000). She stated that [Redacted] JEINMY ESCOBAR-CRUZ (W/F, DOB 10/14/1999), had a verbal argument with her over dying her hair and not wanting to go to the store with her. [Redacted] stated that Jeinmy bossed her around and that she was "fed up". [Redacted] explained that Jeinmy was always trying to get her to fight, but she didn't want to. Jeinmy threw [Redacted]'s phone and then pepper sprayed her across her face with a can of pepper spray on her key-chain.

I then spoke with Jeinmy. She stated that she was also "fed up" with [Redacted] as she had asked [Redacted] to do her hair and [Redacted] gave her attitude. Jeinmy then needed to go to the store to get another box of hair dye product and her mother told [Redacted] to go with her. [Redacted] refused. Jeinmy stated that she then tried to get [Redacted] to fight her by throwing [Redacted]'s phone and, when [Redacted] started walking towards her, she pepper sprayed [Redacted].

Fire Rescue was called to the scene as [Redacted] stated that the pepper spray was in her eyes. [Redacted]'s eyes were somewhat puffy, however they were clear not red. There were no lasting injuries.

At this time, there is probable cause to charge Jeinmy Escobar-Cruz with domestic battery, per F.S.S. 784.03(1a1).
