D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I responded to the area of the 100 block of Black Ironwood Court in reference to a just occurred crash. Upon my arrival I observed a black Nissan bearing New York License Plate HGY8803 facing north on the west side of the road. It had significant front end damage. There was a 2013 Chevrolet pickup bearing Florida License Plate 056TQV in a parking space immediately to the west of the Nissan. It had front end damage and a flat front driver's side tire. A female identified to me as Jenna Bracchi was standing near the pickup along with Charles Robertson, who heard the crash and observed Bracchi in actual physical control of the Nissan immediately after.

OBSERVATION OF DRIVER:

Bracchi had bloodshot, glassy eyes. Bracchi's speech was slurred. I could smell the odor of an unknown alcoholic beverage on her breath.

DRIVER'S STATEMENTS:

Post Miranda, Bracchi stated that she had one marguerita at Duffy's, where she works. Bracchi denied drinking anything else. Bracchi stated on a scale of 1-10 for intoxication she felt like a, "two point five."

ODORS:

Odor of unknown alcoholic beverage on breath



WALK & TURN:

Bracchi list her balance during the instruction phase twice and started early. During the first nine steps, Bracchi stopped for balance on the fifth step. Bracchi turned improperly, pivoting on the balls of her feet. On the second nine steps, Bracchi missed the line and heel to toe on the first step. Bracchi then stepped off the line with her rear foot after placing her front foot on the line. Bracchi used her arms for balance at this time also. Bracchi stepped off the line to the right on the second step. Bracchi kept her arms out to her side until the 6th step. Bracchi stopped to regain her balance on the 8th step. Bracchi took and counted to 10 steps on the return phase.

ONE LEG STAND:

Bracchi used her arms for balance throughout. Bracchi put her foot down on the 3rd and 5th counts. Bracchi changed feet and put her foot down on the 10th count. Bracchi then changed feet again. Bracchi was visibly swaying throughout the exercise. Bracchi did not count as instructed (1000-1, 1000-2, etc) but counted conventionally instead.

FINGER TO NOSE

L1: Bracchi touched the tip of her nose with the pad of her finger. Bracchi forgot to put her finger back down to the side. I reminded her to do so. R2: Bracchi touched the tip of her nose with her finger near the first knuckle. L3: Bracchi touched the tip of her nose with the pad of her finger. R4: Bracchi touched the tip of her nose with the pad of her finger. R5: Bracchi touched the tip of her nose with her finger near the first knuckle. L6: Bracchi touched the tip of her nose with the pad of her finger.

ROMBERG ALPHABET:

Bracchi was swaying visibly during the exercise. Bracchi stated the alphabet correctly until saying "G" instead of "Z".
