PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The defendant was involved in a traffic crash (Case #19127396). D/S J Forges and D/S M Borut responded and observed the driver sitting in her vehicle with the engine running. The defendant was the sole occupant. The defendant told D/S Borut that she believed she was going to get a DUI because she drank too much. Upon my arrival I also observed the defendant sitting in the driver seat of her vehicle, crying. The defendant told me she was driving at the time of the accident and was distracted, on her phone.

OBSERVATION OF DRIVER:

I approached the vehicle on the driver side and met with the driver. I observed the driver was a white female who was wearing shorts and a t-shirt. The driver was crying and had her head tilted down toward her lap. I asked the driver if she was okay and she didnt answer. I continued to ask the driver if she was okay and she just blankly stared at me while crying. I asked the defendant to exit the vehicle. The defendants eyes were extremely watery and bloodshot. The defendant swayed while standing still.

DRIVER'S STATEMENTS:

I asked Jenna if she had been drinking or used any drugs. Jenna told me that she "drank too much" and "shouldn't be driving". Jenna also stated that she felt "fucked up" meaning intoxicated. I asked Jenna if she took any drugs and she stated, "no just alcohol". The defendant told me she was at an unknown bar in Boca where she drank 3 or more "tito's" vodka drinks.

Obvious odor of an unknown alcoholic beverage

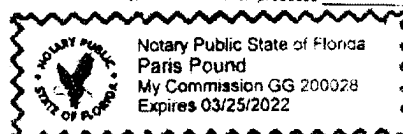

Other Observations:

A red stream-light stylus was used for this exercise. The defendant swayed while standing. The def had equal pupil size and equal tracking. Def displayed lack of smooth pursuit in both eyes, distinct and sustained nystagmus, nystagmus prior to 45 degrees. There was also slight vertical nystagmus.

WALK & TURN:

I created a line using blue tape, which was on a smooth and level surface, free of any debris and well lit by the headlights on my vehicle and near by street lighting. Once placed into the instructed position, I explained and demonstrated the rest of the task. The defendant was unable to maintain the starting position. The defendant started too early. During the task, I observed the defendant swayed while balancing, did not touch heel to toe on the majority of the steps, and made an improper turn by taking both feet off the line and turning around.

ONE LEG STAND:

I placed DRIVER with her feet together and arms at her side. Once the driver was placed into the instructed position, I explained and demonstrated the rest of the task. Once the driver stated she understood, the task was performed. During the task, I observed that Jenna could not maintain the instructed position, swayed while standing stationary and swayed while balancing. Jenna put her foot down 3 times within 30 seconds. Jenna was unable to keep her foot up for longer than 9 seconds.

FINGER TO NOSE:

Jenna stated that she understood the instructions. Jenna did not keep her head tilted back the entire time. Jenna did not keep her eyes closed as instructed.

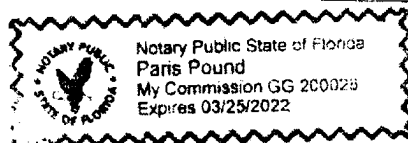
