

The defendant was clearly instructed to await the completion of the instructions prior beginning the task. The defendant acknowledged that they clearly understood my instructions prior to me beginning my instructions for the task. The defendant stated that they clearly understood my instructions for the task. I placed my stimulus in front of the defendant and ask the defendant if they could see it to which he said yes. I asked the defendant what color the stimulus was to which they answered. "blue." I asked the defendant to touch the tip of the stimulus with his finger which the defendant did without issue. Upon commencing the Pen Light Task (HGN) the defendant moved their head side to side in lieu of following with their eyes only, anticipated the stimulus, and/or did not follow the stimulus. I had to reinstruct the defendant multiple times during the task to follow the stimulus with their eyes only. During the task I observed that the defendant had equal pupil size and did not exhibit resting nystagmus. The defendant's eyes tracked equally.</p> <p><b>Modified Romberg:</b> The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. The defendant mimicked me by tilting their head back prior to me telling them to begin. I asked the defendant if they knew how long half a minute was. The defendant stated to me that half a minute is 30 seconds. The defendant estimated 30 seconds to be approximately 40 seconds. When I asked her how she got to that time she stated she counted to 30.</p>

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was dispatched to the the intersection S Military Trl and Lantana Rd, in reference to a female that was asleep behind the wheel. I responded to the intersection and I saw defendant's vehicle, a White Chevrolet Malibu bearing FL tag 680NWQ. The vehicle was stopped at the green light and the white female was asleep in the driver seat. As I approached the motor vehicle was on and the motor was running. The vehicle was in drive and the defendant had her foot on the brake. Palm Beach County Fire Rescue (Run #17-010827) arrived on scene around the same time I did. PBCFR and I shook the vehicle and banged on the windows with no reaction from the driver. PBCFR broke the rear rear window of the vehicle in order to make entry. We were able to shake the female awake. Once the door was open I could obvious odor of an unknown alcoholic beveage coming from her person which intensified as she spoke. PBCFR checked the defendant and said they she appeared to be normal. They stated that she had a blood sugar level or 73 which is normal.

## OBSERVATION OF DRIVER:

PBCFR asked the defendant, later identified by FL DL as, Jenna Jensen. to step out of the vehicle. I observed that the defendant had red, watery, bloodshot eyes. The defendant had the odor of an unknown alcoholic beverage, based on my training and life experiences, that came from their breath which intensified as they spoke to me. I asked the defendant if they had any medical problems and the defendant said no. The defendant was swaying on her feet. I asked how much they had had to drink. The defendant said 4 or 5 vodkas.

I asked the defendant to perform voluntary roadside tasks consented.

I conducted the Standardized Field Sobriety Tasks (SFSTs) in front of D/S J. Shear # 7047 with the following results;

## DRIVER'S STATEMENTS:

Pre Miranda / spontaneous roadside admissions: The defendant stated that she had been at Clematis and while there she had 4 to five vodkas. She stated that she had no medical issues to include diabetes, vertigo, or seizure disorder. I asked her if she had any reason to be asleep other then the fact that she had been drinking and she said no.

## ODORS:

I could smell the obvious odor of an unknown alcoholic beverage, based on my training and experience, that came from the defendant and intensified as the defendant spoke to me.

## GENERAL OBSERVATIONS

SPEECH: normal,

ATTITUDE: polite, friendly, laughing, (post arrest upset) The defendant giggled through out all task.

CLOTHING: Blue Jeans, Black Shoes

MEDICAL/OTHER: I conducted the Standardized Field Sobriety Tasks (SFSTs) in front of D/S J. Shears 7047 PBSO patrol vehicle in car video system with the following results; Defendant states no medical problems or medications.

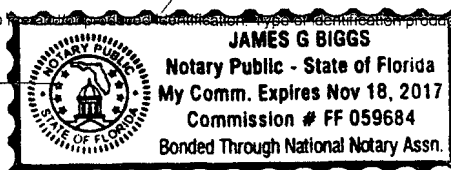

## WALK &amp; TURN:

I had the defendant use a straight line that was located on the ground. I had the defendant place their left foot on the line with their right foot in front of the left, heel to toe. I told the defendant to remain in the position throughout my instructions and demonstration. The defendant was instructed not to start the task prior to me telling them to begin. The defendant acknowledged and stated they completely understood my instructions. The defendant was then instructed on the task which was also demonstrated. The defendant swayed during my instructions. The defendant came out of the stance prior to me telling him to begin. Once the task was started the defendant missed heel to toe, used their arms for balance, made an improper turn, slowed to balance/steady their self, and spontaneously stopped prior to completing the task. The defendant asked for additional instructions, and swayed throughout completing the task.

## ONE LEG STAND:

The defendant was instructed to stand with their feet together and their hands down by their side. They were then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood the instructions. The defendant swayed while in the instructional position. After being told to start the defendant put their foot down prior to being told to stop, used their arms for balance, swayed, and hopped. The defendant did not count in the manner instructed. The defendant did not point their toe or look at their toe as instructed after even after being instructed to do so.

## FINGER TO NOSE:

The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. The defendant mimicked me by tilting their head back prior to being told to start. I instructed the defendant on the task and demonstrated the task. The defendant acknowledged the instructions stating that they clearly understood them. The defendant proceeded to miss/search for the tip of their nose with the tip of their finger on multiple times, and did not bring their hand immediately bring back as instructed on every attempt even after numerous reminders to do so. The defendant did not keep their head tilted back and opened their eyes during the task.

## MODIFIED ROMBERG:

The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. The defendant mimicked me by tilting their head back prior to me telling them to begin. I asked the defendant if they knew their English alphabet and she stated that she did. Once told to begin she rushed through the alphabet, saying it without issue.

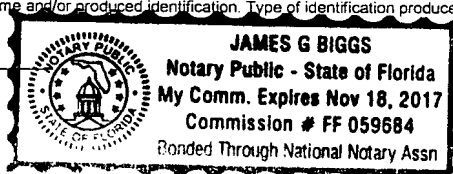
