The second task was the walk and turn. I explained the instructions, demonstrated it, and she stated she understood. It should be noted that while explaining the task to Maser, she started the exercise multiple times before being advised to begin. She was unable to maintain the starting position and used her hands to keep her balance. She didn't touch heal to toe on any step or count out loud. She didn't look down at her feet throughout the exercise and walked thirteen steps down and then ten back. She used her arms throughout the task for balance, stepped off the line, and was unsteady on her feet. The third task was the one leg stand. I explained the instructions, demonstrated it, and she stated she understood. She then began the task. She lifted up her right foot, had her knee bent, and placed it down multiple times throughout the exercise. She did not count aloud, she used her hands for balance, and she did not look at her raised foot throughout the task. I then went onto the next task. The fourth task was the Romberg alphabet. I explained the instructions and she stated she understood. She then began saying the alphabet. She said A-K and then H-I-J and so on until she completed the alphabet. The fifth task I instructed her to put her feet together and arms at her side. I we explained to place her head back and eyes shut and count to 30 seconds in her head. The sixth task was the finger to nose. I explained the instructions and she stated she understood. She then began the task (R-I-R-I-L-I-R). Multiple times throughout the exercise, Maser lifted the incorrect finger, put it down, and touched her nose with the correct finger. The first and second R she touched under her nose. She was unsteady on her feet and swaying back and forth throughout the task. Maser was then placed under arrest for DUI under FSS 316.193(1). Search incident to arrest, Officer Murphy located a clear beggie containing a white powdery substance in the right side of her bra. The powdery substance was later tested and tested positive
