committed the below acts in my presence. was observed by _____ who told _____ that he/she saw the arrested person commit the below acts.

confessed to **D/S D. DUTTENHOEFFER** admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the **15** day of **MARCH** 20**18** at **1055** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On Thursday March 15, 2018 at 0940 hours, I responded to 9339 Glades Road, unincorporated Boca Raton FL, 33434 in reference to assisting CSA Harrison #7366 with a traffic crash. Upon arrival, I met with CSA Harrison and Kyle Vicat, who is employed with Palm Beach County Fire Rescue.

CSA Harrison stated Fire Rescue personnel found a large bag of suspected marijuana, inside one of the vehicles that was involved in the crash. I then spoke with Kyle, who stated he is the one who found the marijuana. Kyle found the marijuana in a white 2018 Jeep, bearing Florida license plate ISKC86, which is registered to Gary Labriola and Jennifer Bellavia. Kyle said Jennifer was involved in the vehicle accident and he asked Jennifer where her driver license was. Kyle said Jennifer told him her driver license was inside her vehicle and located on the driver side door compartment. Kyle said Jennifer gave him permission to retrieve her license and that is when he discovered a plastic bag containing what he believed was marijuana. Kyle said he located Jennifer's license inside the same compartment as the suspected marijuana. Kyle said Jennifer's license, which turned out to be an identification card, was located inside a pocket purse, just under the bag of marijuana. Kyle said once discovering this he informed CSA Harrison.

Kyle showed me the suspected bag of marijuana, which was now lying on the driver seat. The suspected marijuana bag read "Bonafide Connoisseur". The bag was sealed and unopened. I then made contact with Jennifer, who was being evaluated by Fire Rescue. As I approached Jennifer she spontaneously stated the marijuana was not hers and belonged to her boyfriend. Kyle's boyfriend is Gary Labriola, who is also registered to the Jeep. D/S Moss #9195 and I then escorted Jennifer to our patrol vehicles, which she was then read her Miranda Warnings off a preprinted PBSO Miranda Warnings card. Jennifer initialed all of her rights on the card and signed the card as well. Jennifer stated she understood her rights and agreed to speak with me regarding the incident.

Jennifer said this morning she drove her vehicle to the West Boca Medical Center, located at 21644 South State Road 7, unincorporated Boca Raton FL, 33428, because she was not feeling well. Jennifer said she was released a few hours later and proceeded to drive home, where she then was involved in a vehicle accident. Jennifer claims after the accident she told the Fire Rescue personnel her license was located inside her vehicle, and inside the driver side door compartment. Jennifer claims the marijuana belongs to her boyfriend and she also claimed she did not know the marijuana was inside her vehicle. I informed Jennifer her license was found inside the same compartment as the marijuana and she still claimed she had no knowledge of the marijuana being inside the vehicle. It should be noted Jennifer was the only subject inside the vehicle when the accident occurred.

I then made contact with Sgt. Slaughter #5654 and he was informed of this incident. Jennifer was arrested and then transported to the District 7 Office. Once at the office, I met with Agent Trimino #8529, who is assigned to the PBSO Narcotics Division. Jennifer was then escorted inside the office and Agent Trimino and I questioned Jennifer in regards to the marijuana found inside her vehicle. Jennifer again stated it belongs to her boyfriend Gary, who she also referred to him as "Boomer". Jennifer now admitted she knew the marijuana was inside the vehicle and forgot it was there when she told the personnel from Fire Rescue to retrieve her license. Jennifer provided no further information. The suspected marijuana was tested with the Duquenois Reagent Marijuana Hashish-THC tester and revealed a positive test for the presence of THC and the total package weight of the marijuana was 67 grams. D/S Moss completed the property receipt and he placed the marijuana into evidence.

Based on my investigation, I find probable cause does exist to arrest Jennifer for the charge of possession of marijuana over 20 grams, per F.S.S. 893.13 6A.
