

On 10-3-18 I was conducting patrol in the neighborhood of Limestone Creek located in Jupiter Fl. While traveling North on Island Way I observed a white female wearing a blue Tank top and blue shorts riding a blue bicycle with no lights. The white female was traveling North on Island way then made a right turn on to Limestone Creek Road. I then turned on Limestone creek road to catch up to the Female to stop her for violating FSS 316.2065 7. I stopped at Limestone Creek Road and 1st Street and told the female to stop. The Female stopped and immediately said "I was just stopped by Jupiter and I know that I need to get lights on my bike".

The female later identified as Jennifer Weisheit (dob 09-01-1989) stated that she was riding around for a little bit then she was going to go to her house. I asked Jenifer if she had anything in her possession that I needed to know about and she looked down at her cigarette pack and said no all I have are cigarettes. My back-up deputy arrived on scene and I went back to my patrol vehicle to do a records check on Jennifer. While running Jennifer D/S Feddon 31910 was speaking with Jennifer he said he asked her if anything was in the cigarette pack at which time Jennifer opened to cigarette pack to show him. When D/S Feddon 31910 shined his flashlight on the cigarette pack that was still in Jennifer's possession he noticed a white capsule in the top of the pack. D/S Feddon said what's that on top and Jennifer uttered it's heroin and put her head down.

D/S Feddon 31910 gave me the pack of cigarettes which when I opened it up one capsule was sitting right on top and the other was in the front of the pack between two cigarettes. The capsules were white in color. I put on a pair of new latex gloves and opened up each capsule to conduct a field test on. Inside of each capsule was an off white colored powdered substance. I used two new cotton swabs to get a small amount of the substance on each swab to put in two separate test kits to test each capsule. Both tests tested positive for Heroin. Both capsules field tested positive with Marquis reagent test kit(NARK2001).

Jennifer was placed under arrest for possession of heroin FSS 893.18 6a. Jennifer was placed in handcuffs double locked checked for fit and placed in the rear seat of the patrol car. Jennifer was then transported to the Palm Beach County Jail to be booked on her charge.
