
On the above stated day and time, I was dispatched to Target located at 650 N Congress Avenue, Boynton Beach, Palm Beach County, Florida in reference to a theft in progress. It was advised by BBPD Communication Personnel that Target Asset Protection observed an adult w/f later identified as Jennifer Lynn Leah (DOB 07/21/1990) concealing items into her purse.

Upon arrival contact was made with leach as she exited the store at which time she was detained. Contact was made with Senior Asset Protection Specialist Brian Vargas who advised the following: At approximately 1531 hours, Leach was observed entering the businesses shoe department and concealing a pair of slippers in her purse. Vargas continued to observe Leach via on floor surveillance as she entered the womens clothing department and select numerous clothing articles and remove them from the hangers before concealing them in her purse. Leah was then observed entering the jewelry section where she removed jewelry items from their display and concealed them. Leach was then observed exiting the business passing all point of sale failing to render payment.

Upon detaining Leach all items were recovered and turned over to Target Personnel. The total value of the merchandise stolen is \$407.8. Vargas provided a receipt for the merchandise. Vargas provided a sworn statement captured via BWC in addition to in store surveillance footage of the incident. N/FCIC checks were completed yielding negative results. Leach was trespass in my presence by Target Asset Protection Specialist Vargas for a period of 1 year. Leach advised she understood.

Based on the above, Jennifer Lynn Leach was arrested for (1) count of Retail Grand Theft per F.S.S. 812.015.8. Leach was placed into handcuffs (D/L and checked for tightness), transported to BBPD for processing, and subsequently TOT to PBCJ without further incident.
