On the above date and time I responded to 124 Camden F, within the Century Village Community, in reference to a police service call. Dispatch advised that the complainant was concerned about a vehicle that was parked in an improper parking spot, and the vehicle appeared to be occupied. The vehicle was described as being a green 2-door car.

Upon arrival, I located a green Chrysler 200 4-door vehicle parked in the parking spot of 124 Camden F. The complainant, who wished to not be involved in my investigation, pointed to the car and stated "thats it". I ran the tag on the Chrysler (FL: ANHH88) which resulted in an address within the same Century Village Community. I approached the vehicle from the passenger side and observed a white female behind the wheel of the running vehicle. The female appeared to be asleep as her eyes were closed and her head was slumped over. I walked to the driver side of the vehicle and knocked on the driver side window several times, which startled the female. She was extremely lethargic and slow moving. In her lap I observed a black bag w th many orange and white syringes protruding through the top of the open bag. She opened the door slightly at which time I requested for her to step out without touching what was in her lap. She exited the car, and I directed her to stand along the trunk of her vehicle.

I asked the female if she needed an ambulance to check her out for her suspected drug use, but she declined. The female was later identified as Jennifer Melley by Florida Driver's License. I asked Jennifer if she had any medical condition that required the extensive use of such needles that were in her lap, to which she denied. I asked if she had a drug problem, to which she confirmed and stated that she has a heroine addiction. I asked Jennifer if she uses the needles to inject heroine, to which she confirmed positively. I then inquired if Jennifer has any heroine inside of the vehicle, to which she stated she was unsure, but mentioned "it's totally fine for you to look". Jennifer was detained into department issued handcuffs and placed in the rear of my patrol vehicle pending further investigation.

I located a multicolored purse on the driver seat which contained a wallet with Jennifer's identification. Inside of the purse were three more needles, which had an unknown liquid substance in the center. The substance appeared clear with a minor tint of a darker substance. On the passenger seat was a prescription container belonging to an "Arlan Gootman". I looked inside of the contained and observed


multiple clear capsules with a white powdery substance in the middle. I suspected that the capsules contained heroine, but was not field tested due to the possible containment of fentanyl. Also on the driver seat was a burnt spoon, and a green plastic band used as a form of a tourniquet, all consistent with the personal use of heroine.

I asked Jennifer if she injected heroine today, to which she confirmed approximately 5 hours earlier. Upon hearing this, I requested Rescue respond to check the welfare of Jennifer. She was treated on scene by Rescue 23 personnel. I asked Jennifer if she was willing to tell me where she bought the heroine from, to which she advised she bought it at the Cumberland Farms located at the intersection of Forest Hill BLVD and Kirk Rd by a white male whom she only knows as "Jay". Jennifer then continued by stating that she believes that the heroine was cut with "elephant tranquilizer" and added that she has "never passed out from injecting heroine before".

Due to not being able to confirm that the suspected heroine was in fact heroine, Jennifer was released with an NTA for possession of drug paraphernalia with a court date of January 25, 2017 at the North County Courthouse. Jennifer signed for the NTA and was released with her own copy. The drug paraphernalia was submitted into evidence for trial. The syringes with the unknown liquid, and the capsules containing the powder were submitted into evidence to be tested. A warrant request will be forthcoming pending the drug test results.

This case is cleared by arrest under case number 16-171164.

On 01/13/17 I received a drug laboratory chemistry report from Marcus Warner, PBSO Senior Forensic Scientist, advising of the result of the submitted suspected heroine in the prescription container. It was advised that there were two clear capsules containing tan colored powder, nine clear capsules containing tan colored powder residue, and one white tablet piece. One of the clear capsules containing the tan colored powder was analyzed and resulted in a positive indication of Heroin (Schedule I) and Fentanyl (Schedule II) with a net weight of .0755 G and a coverage probability of 99.73%. The white tablet piece of was analyzed with a positive indication of Alprazolam (Schedule IV) also known as Xanax, with a net weight of .0482 G and a coverage probability of 99.73%.

Based on the positive confirmation for the pills containing heroine, the possession of the single Alprazolam pill, and the admission provided by Jennifer for the presence of the drugs, I find probable cause for the charges of possession of heroine -FSS 893.16(6)(A) and possession of a controlled substance - FSS 893.13(6) (A). Tracking citations A5SE36E and A5SE35E were printed and submitted with the case file. This case is to be forwarded to the State Attorney's Office for review.
