<p>On the above date and time while on patrol in the area of Palmetto Park Rd Westbound and the Florida turnpike overpass I was traveling in the right lane. I observed a vehicle in the center lane behind me approximately 4-5 vehicles back. The vehicle was traveling with its high beams on in contrary to Florida State Statue 316. 238 (1)(B) failure to dim when approaching another vehicle from behind within 300 feet. There was another vehicle in front of the defendants and one more traveling in the inside lane. I slowed my vehicle down and allowed all vehicles to pass my marked patrol vehicle. I changed lanes to the rear of the defendant's vehicles and activated my emergency lights to have the vehicle pull over. The driver later identified as the defendant turned down her high beams and pulled over in the right hand turn lane to go northbound on Lyons Rd. I approached the driver's side window and observed a single occupant driver and identified myself and advised her why she was being pulled over. I asked for her driver's license, registration, and insurance paperwork. The defendant produced her driver's license without any problems, but then fumbled through her glove box to find her other paperwork. She pulled out papers from the glove box and started rifling through them. She then pulled out her owner's manual and started pulling out manual from there. She then opened her center console and started looking through papers and finally gave up. She then started looking inside her driver's door panel for her paperwork and then stated she couldn't find it. I detected an odor of unknown alcoholic beverage coming from the defendant as she spoke to me and her eyes were red and watery. At that time, I called for a traffic unit to take over the traffic stop.</p>

On 27Jul17 at approximately 2316hrs, Sgt. R. Ugalde (7669) was traveling westbound in his marked patrol vehicle on Palmetto Park Rd, Boca Raton, in unincorporated Palm Beach County. He observed a vehicle traveling westbound approaching the rear of his vehicle. He told me the vehicle was had its high beams and failed to dim them when approaching his vehicle from behind. He allowed the vehicle to pass his vehicle and then got behind the vehicle. The vehicle was black Lexus SUV (FL tag 129TLM). Sgt. Ugalde pulled his vehicle in behind the Lexus and activated his emergency lights. The vehicle immediately dimmed its lights and pulled into the right hand turn lane on Palmetto Park Rd at the intersection of Lyons Rd.

OBSERVATION OF DRIVER:

Sgt. Ugalde told me he approached the driver's side window a white female in the driver's seat; she was later identified as Jennifer Houston by her Florida Driver's license. He asked for her driver's license, registration, and insurance paperwork. Jennifer produced her driver's license without any problems, but then fumbled through her glove box to find her other paperwork. She pulled out papers from the glove box and started rifling through them. She then pulled out her owner's manual and started pulling out the manual. She then opened her center console and started looking through papers and finally gave up. She then started looking inside her driver's door panel for her paperwork and then stated she couldn't find it. He told me he "detected an odor of unknown alcoholic beverage coming from the defendant (Jennifer) as she spoke" and he stated her "eyes were red and watery".

After arrival I made contact with Jennifer. She was sitting in the driver's seat of the Lexus and the vehicle was running. On approach to the vehicle I observed an unopened bottle of Coppola Pinot Noir on the back seat next to a child seat. I could smell the odor an unknown alcoholic beverage coming from inside the vehicle and from her breath. Her eyes were watery and bloodshot. I had her exit the vehicle and stand at the back of her vehicle. She was wearing black high heels. While she was standing and while wearing these shoes her body swayed. I requested she removed her shoes to perform the Standard Field Sobriety Tasks (SFST). She bent over and untied the band on both shoes. She then walked to the rear of her vehicle and used it for support to remove her shoes. I then had her stand in the same position. Her body swayed with the shoes removed. I again could smell the odor of an unknown alcoholic beverage coming from her person and from her breath.

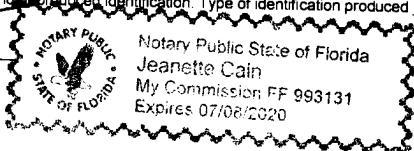

She indicated the area was too rough, so we moved the center of the right turn lane to complete the task. Again I instructed and demonstrated the task. She acknowledged she understood. She could not stand as instructed and had to step off the line. She had difficulty standing with her right foot directly in front of her left foot. She walked 8 steps forward (she counted her stance as step 1). She missed touching heel to toe. She then completed the turn incorrectly. She walked 9 steps back. She missed heel to toe on several steps and stepped off the line (crossed her feet while walking). The task was completed on a dry and level surface.

I instructed and demonstrated the one leg stand. She acknowledged she understood but refused to do anymore tasks. I explained the Taylor Warning to her again and she again refused to complete anymore tasks.

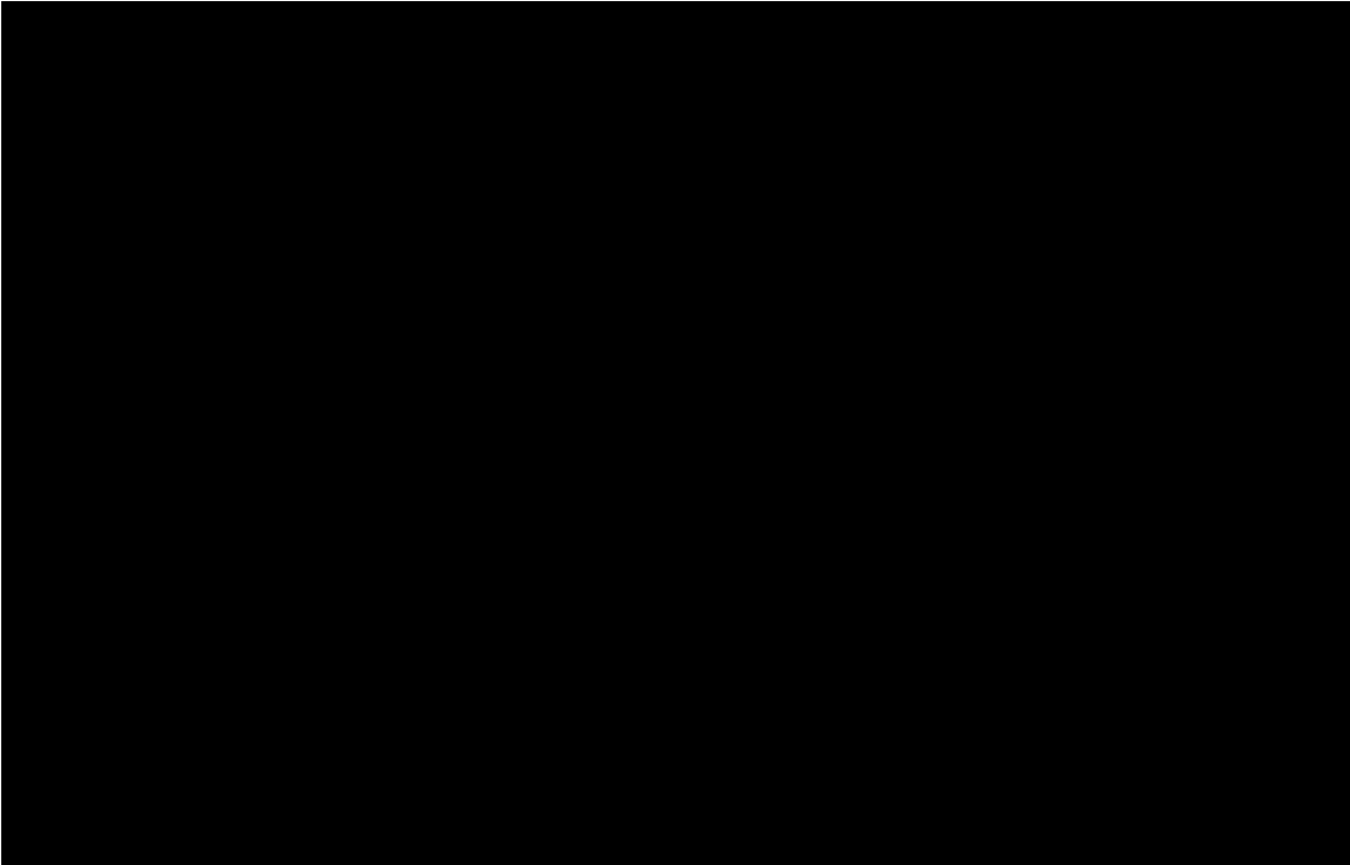
